

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Christopher Nickell DOCKET NO.: 18-46281.001-R-1 PARCEL NO.: 10-34-402-016-0000

The parties of record before the Property Tax Appeal Board are Christopher Nickell, the appellant(s), by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$7,875 IMPR.: \$28,453 TOTAL: \$36,328

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 57-year-old, multi-level, single-family dwelling of masonry construction. The improvement contains 1,929 square feet of living area, a partial basement with a formal recreation room, central air conditioning, a fireplace and a two-car garage. The property is sited on 9,000 square feet of land and is located in Lincolnwood, Niles Township, Cook County. The subject is classified as a class 2-34, residential property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of the market value argument, the appellant submitted four sales comparables. The comparables had the same assessment neighborhood code as the subject however, the exact proximity to the subject was not provided by the appellant. The comparables are described as, multi-level single family dwellings of masonry construction. They range in age from 56 to 61 years and in size from 1,377 to 2,088

square feet of building area. The sales occurred from November 2016 to June 2018 for prices ranging from \$163.93 to \$174.81 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's total assessment to \$32,648.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's total assessment of \$36,328 with an improvement assessment of \$28,453 or \$14.75 per square foot of building area. The total assessment reflects a market value of \$363,280 or \$188.33 per square foot of building area, including land, using the Cook County Real Property Assessment Classification Ordinance level of assessment for class 2 property of 10%.

In support of the assessment the board of review submitted one sales comparables described as a multi-level, single-family dwelling of masonry construction that sold November of 2018 for \$253.85 per square foot of building area, including land.

Based on this evidence the board of review requested confirmation of the subject's assessment.

# **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c).

The Board finds the best evidence of market value to be the appellant's comparables #1, #3 and #4 and the board of review's comparable #1. These three comparables had sales prices ranging from \$163.93 to \$253.85 per square foot of building area, including land. In comparison the subject's assessment reflects a market value of \$188.33 per square foot of building area, including land is within the range of the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate by a preponderance of the evidence that the subject was overvalued and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
