

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Eric & Mariana Kochman

The parties of record before the Property Tax Appeal Board are Eric & Mariana Kochman, the appellants, by attorney Steven Kandelman, of Rieff Schramm Kanter & Guttman in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$108,165 **IMPR.:** \$415,265 **TOTAL:** \$523,430

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of stone and brick exterior construction with 6,089 square feet of living area. The dwelling was constructed in 2007. Features include a full basement with a recreation room, central air conditioning, two fireplaces and a 729 square foot garage. The subject property has a 23,420 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument the appellants submitted information on four comparable sales located outside the subject's neighborhood. The comparables consist of two-story dwellings of brick and stone, brick, or wood siding exterior construction that were built from 2000 to 2007. The dwellings range in size from 5,198 to 5,820 square feet of living area and are situated on sites that range in size from 19,020 to 29,630 square feet of land area. The comparables have full basements with a

recreation room, central air conditioning, one or two fireplaces and a garage ranging in size from 675 to 816 square feet of building area. One comparable has a plastic liner pool with a bath house. The comparables sold from May 2018 to December 2019 for prices ranging from \$930,000 to \$1,425,000 or from \$159.79 to \$246.80 per square foot of living area, including land. Based on this evidence, the appellants requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$523,430. The subject's assessment reflects an estimated market value of \$1,591,456 or \$261.37 per square foot of living area, including land, when applying the 2019 three-year average median level of assessment for Lake County of 32.89%.

In support of the subject's assessment, the board of review submitted information on four comparable sales located outside the subject's neighborhood. The comparables consist of two-story dwellings of brick, stone, or brick and stone exterior construction that were built from 1939 to 2008. Comparable #1 has an effective year built of 1946. The dwellings range in size from 5,376 to 6,432 square feet of living area and are situated on sites that range in size from 20,100 to 39,200 square feet of land area. The comparables have full basements with a recreation room, central air conditioning, three or five fireplaces, and a garage ranging in size from 716 to 1,066 square feet of building area. Comparables #1 and #2 each have a plastic liner pool. The comparables sold from April 2017 to August 2018 for prices ranging from \$1,950,000 to \$2,650,000 or from \$303.17 to \$492.93 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The record contains eight comparable sales for the Board's consideration. Notwithstanding that one comparable sold in 2017, which is dated in relation to the subject's January 1, 2019 assessment date, the Board finds neither of the parties' comparables are particularly similar to the subject due to differences in location, age, dwelling size and/or features. Nevertheless, these comparables sold from April 2017 to December 2019 for prices ranging from \$930,000 to \$2,650,000 or from \$159.79 to \$492.93 per square foot of living area, including land. The subject's assessment reflects an estimated market value of \$1,591,456 or \$261.37 per square foot of living area, including land, which falls within the range established by the comparable sales in this record. Furthermore, removing the high and low sales results in a range of \$201.14 to \$357.08 per square foot of living area, including land, which supports the subject's current estimated market value based on its assessment. After considering the numerous adjustments to the comparables for differences when compared to the subject like location, age, dwelling size, and features, the Board finds the subject's estimated market value as reflected by its assessment is supported and no reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
