

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Seyed Adnani DOCKET NO.: 19-03942.001-R-1 PARCEL NO.: 16-36-123-033

The parties of record before the Property Tax Appeal Board are Seyed Adnani, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$52,961 **IMPR.:** \$58,004 **TOTAL:** \$110,965

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a tri-level dwelling of brick exterior construction with 1,378 square feet of above grade living area. The dwelling was constructed in 1955 and is approximately 64 years old. Features of the home include a finished lower level, a fireplace and a 308 square foot garage. The property has approximately a 5,210 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables located within the same assessment neighborhood code as the subject. The comparables are improved with tri-level dwellings of brick or vinyl siding exterior construction that range in size from 992 to 1,653 square feet of above grade living area and range in age from 64 to 78 years old. Each comparable has a lower level, with two having finished area; two comparables have central air conditioning; and each comparable has a fireplace and a garage

ranging in size from 280 to 352 square feet of building area. The comparables have improvement assessments ranging from \$39,240 to \$65,113 or from \$37.31 to \$39.56 per square foot of above grade living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$110,965. The subject has an improvement assessment of \$58,004 or \$42.09 per square foot of above grade living area. In support of its contention of the correct assessment the board of review submitted information on five equity comparables that are located within the same assessment neighborhood code as the subject. The comparables are improved with tri-level dwellings of brick or brick and wood siding exterior construction that range in size from 1,254 to 1,413 square feet of living area and were built from 1953 to 1961. Each comparable has a finished lower level and central air conditioning. Three comparables each have a fireplace. Three comparables have garages ranging in size from 264 to 575 square feet of building area. The comparables have improvement assessments ranging from \$46,060 to \$65,810 or from \$36.73 to \$47.85 per square foot of above grade living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight equity comparables for the Board's consideration. The Board gave less weight to the appellant's comparables due to their differences in dwelling size and age when compared to the subject. The Board also gave less weight to board of review comparables #3 and #4 as each lacks a garage, a feature of the subject.

The Board finds the best evidence of assessment equity to be board of review comparables #1, #2 and #5 which overall are most similar to the subject in location, design, age, dwelling size and features. These comparables have improvement assessments ranging from \$61,134 to \$65,810 or from \$46.17 to \$47.85 per square foot of above grade living area. The subject has an improvement assessment of \$58,004 or \$42.09 per square foot of above grade living area, which falls below the range established by the best comparables in this record. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not prove by clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
