

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Arnold Schwartz, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$78,111 **IMPR.:** \$175,531 **TOTAL:** \$253,642

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 1.75-story dwelling of wood siding exterior construction with 3,160 square feet of living area. The dwelling was built in 1988 and is approximately 31 years old. Features of the home include a basement with a recreation room, central air conditioning, a fireplace and a 759 square foot garage. The property has a 13,400 square foot site and is located in Lake Forest, West Deerfield Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located within the same assessment neighborhood code as the subject property. The comparables are described as two-story dwellings of wood siding or brick exterior construction ranging in size from 2,523 to 3,270 square feet of living area. The dwellings range in age from 31 to 35 years old. Each comparable has an unfinished basement and central air conditioning.

Three comparables each have a fireplace and a garage ranging in size from 496 to 566 square feet of building area. Comparable #2 appears to have an attached garage per the photographic evidence provided by the appellant. The comparables have improvement assessments ranging from \$90,761 to \$109,832 or from \$31.30 to \$37.43 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$253,642. The subject property has an improvement assessment of \$175,531 or \$55.55 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located within the same assessment neighborhood code as the subject property. The comparables are described as two-story dwellings of brick or wood siding exterior construction ranging in size from 3,330 to 3,511 square feet of living area. The dwellings were constructed from 1985 to 1996. Comparable #3 has an effective age of 1991. The comparables have basements, with one having a recreation room. Each comparable has central air conditioning, one or two fireplaces, and a garage ranging in size from 420 to 805 square feet of building area. Comparable #2 has an inground swimming pool. The comparables have improvement assessments ranging from \$181,415 to \$203,168 or from \$54.11 to \$58.10 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The parties submitted eight equity comparables for the Board's consideration. The Board gave less weight to appellant's comparable #4 due to its smaller dwelling size, board of review comparable #2 which has an inground swimming pool and board of review comparable #4 which is a newer dwelling when compared to the subject. The Board finds the best evidence of assessment equity to be the parties' remaining comparables which are relatively similar to the subject in location, age, dwelling size and some features. However, five of the comparables have inferior unfinished basements and four of the comparables have smaller garages when compared to the subject. These comparables have improvement assessments ranging from \$90,761 to \$189,963 or from \$31.30 to \$54.48 per square foot of living area. The subject's improvement assessment of \$175,531 or \$55.55 per square foot of living area falls within the range on an overall basis established by the best comparables in the record but slightly above on a square foot basis. However, after considering adjustments to the best comparables for differences in features when compared to the subject, the Board finds the appellant did not prove by clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
