

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Justin Southwell DOCKET NO.: 19-04937.001-R-1 PARCEL NO.: 11-14-402-013

The parties of record before the Property Tax Appeal Board are Justin Southwell, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$48,584 **IMPR.:** \$154,716 **TOTAL:** \$203,300

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of frame exterior construction with 3,718 square feet of living area. The dwelling was constructed in 1996. Features of the home include an unfinished basement, central air conditioning, two fireplaces and a 674 square foot garage. The property has a 20,186 square foot site and is located in Green Oaks, Libertyville Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on three comparable sales located within 0.25 of a mile from the subject property. The comparables have sites that range in size from 19,530 to 23,680 square feet of land area and are improved with two-story dwellings of frame or brick and frame exterior construction that range in size from 3,718 to 3,982 square feet of living area. The dwellings were built from 1996 to 1999. Each comparable has an unfinished basement, central air

conditioning, one to three fireplaces and a garage ranging in size from 655 to 910 square feet of building area. The properties sold from June 2018 to June 2019 for prices ranging from \$520,000 to \$635,000 or from \$130.59 to \$166.45 per square foot of living area, land included.

The appellant's grid analysis also included a 2017 prior sale of the subject property for a price of \$610,000 or \$164.07 per square foot of living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$183,403 which reflects a market value of \$550,264 or \$148.00 per square foot of living area, land included, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$206,046. The subject's assessment reflects a market value of \$626,470 or \$168.50 per square foot of living area, land included, when using the 2019 three year average median level of assessment for Lake County of 32.89% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on three comparable sales located within 0.25 of a mile from the subject property. Board of review comparable #3 is the same property as the appellant's comparable #3. The comparables have sites that range in size from 23,143 to 23,671 square feet of land area and are improved with two-story dwellings of frame, brick or brick and frame exterior construction that range in size from 2,905 to 3,815 square feet of living area. The homes were built from 1996 to 1999. Each comparable has an unfinished basement, central air conditioning, one or three fireplaces and a garage ranging in size from 441 to 910 square feet of building area. The properties sold from June 2018 to June 2019 for prices ranging from \$568,750 to \$635,000 or from \$166.45 to \$200.26 per square foot of living area, land included.

The board of review also submitted a copy of the 2017 Multiple Listing Service sheet on the sale of the subject for \$610,000 and reiterated this sale of the subject in their grid analysis. Based on this evidence, the board of review requested the subject's assessment be confirmed.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The record contains five comparable sales for the Board's consideration as one property was common to both parties. The Board gives less weight to the board of review comparables #1 and #2 which differ from the subject in dwelling size.

The Board finds the best evidence of market value to be the remaining comparables which are more similar to the subject in location, age, design, dwelling size and features. These comparables sold from June 2018 to June 2019 for prices ranging from \$520,000 to \$635,000 or

from \$130.59 to \$166.45 per square foot of living area, land included. The subject's assessment reflects a market value of \$626,470 or \$168.50 per square foot of living area, including land, which falls within the range established by the best comparable sales in this record on an overall basis and above the range on a per square foot basis. The Board finds the subject's 2017 sale of \$610,000 or \$164.07 per square foot of living area, land included, falls within the range of the best comparables in the record. After considering adjustments to the comparables for differences from the subject, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
