



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Jessica Cohen

The parties of record before the Property Tax Appeal Board are Jessica Cohen, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$122,559
IMPR.: \$211,602
TOTAL: \$334,161

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of brick exterior construction with 3,787 square feet of living area. The dwelling was constructed in 1977 and is 42 years old. Features of the home include a basement with finished area, central air conditioning, two fireplaces, and a 606 square foot garage. The property has an approximately 17,358 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellant contends assessment inequity concerning the improvement assessment as the basis of the appeal; no dispute was raised concerning the land assessment. In support of this argument the appellant submitted information on four equity comparables improved with two-story homes of brick or wood siding exterior construction ranging in size from 3,473 to 4,417 square feet of living area. The dwellings were built from 1989 to 1995 and are from 24 to 30 years old. The homes each have a full basement, with one of the homes having finished area, central air

conditioning, a fireplace, and a garage ranging in size from 462 to 751 square feet of building area. The comparables are located within 0.19 of a mile from the subject property and are within the same assessment neighborhood code as the subject property. The comparables have improvement assessments reported by the appellant ranging from \$146,587 to \$217,332 or from \$42.13 to \$49.20 per square foot of living area. Based upon this evidence, the appellant requested the subject property's improvement assessment be reduced to \$168,426 or \$44.48 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$334,161. The subject property has an improvement assessment of \$211,602 or \$55.88 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on six equity comparables, where the board of review's comparable #3 is the same as the appellant's comparable #1. The properties are improved with two-story homes of brick, wood siding, or brick and wood siding exterior construction ranging in size from 3,599 to 3,895 square feet of living area. The dwellings were built from 1936 to 1995 with the home built in 1936 having a reported effective age of 1951. The homes each have a full basement, four of which have finished area. The comparables each have central air conditioning, one or two fireplaces, and a garage ranging in size from 450 to 836 square feet of building area. The comparables are located from 0.14 to 1.09 miles from the subject property and are within the same assessment neighborhood code as the subject property. The comparables have improvement assessments ranging from \$201,947 to \$229,464 or from \$53.25 to \$61.09 per square foot of living area. Based upon this evidence, the board of review requested confirmation of the subject property's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the evidence of record does not support a reduction in the subject's assessment.

The record contains a total of nine comparables, with one common property, for the Board's consideration. The Board gives less weight to the appellant's comparable #1/board of review's comparable #3, the appellant's comparables #2 and #3, and the board of review's comparable #6, due to their lack of finished basement area which the subject features.

The Board finds the best evidence of assessment equity to be the appellant's comparable #4 and the board of review's comparables #1, #2, #4, and #5, which are similar to the subject in dwelling size, location, and most features. These comparables have improvement assessments that range from \$201,947 to \$229,464 or from to \$49.20 to \$61.09 per square foot of living area. The subject's improvement assessment of \$211,602 or \$55.88 per square foot of living area falls

within the range established by the best comparables in this record. Based on this record, and after considering appropriate adjustments to the comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
