

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Justin Wellen, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$148,025 **IMPR.:** \$162,500 **TOTAL:** \$310,525

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of stone exterior construction with 3,693 square feet of living area. The dwelling was constructed in 1951, is 68 years old and has an effective year built of 1959. Features of the home include a basement with finished area, central air conditioning, one fireplace and a 437 square foot garage. The property has a 27,693 square foot site¹ and is located in Highland Park, Moraine Township, Lake County.

The appellant contends assessment inequity, with respect to the improvement assessment, as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located in the same assessment neighborhood code as the subject. The comparables are improved with two-story dwellings of brick, stucco or stone exterior

construction that range in size from 3,333 to 4,993 square feet of living area. The homes range in age from 78 to 92 years old. Each comparable has a basement, two with finished area, central air conditioning, two fireplaces and a garage ranging in size from 360 to 600 square feet of building area. The comparables have improvement assessments that range from \$129,831 to \$183,320 or from \$36.72 to \$39.07 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$140,334 or \$38.00 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$318,432. The subject has an improvement assessment of \$170,407 or \$46.14 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located in the same assessment neighborhood code as the subject property. The comparables are improved with two-story dwellings with a mix of brick, stone or wood siding exterior construction that range in size from 3,379 to 3,712 square feet of living area. The homes were built from 1933 to 1950 and have effective ages ranging from 1956 to 1964. Each comparable has a basement with finished area, central air conditioning, one or two fireplaces and a garage ranging in size from 338 to 874 square feet of building area. Comparable #2 also features an inground swimming pool. The comparables have improvement assessments that range from \$157,771 to \$182,447 or from \$44.30 to \$49.15 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments, for the assessment year in question, of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted eight equity comparables for the Board's consideration. The Board gives less weight to the appellant's comparables along with board of review comparables #2 and #4 which differ from the subject in age, dwelling size, unfinished basement and/or feature an inground swimming pool, unlike the subject.

The Board finds the best evidence of assessment equity to be the remaining two comparables which are more similar to the subject in location, age/effective age, dwelling size and features. These comparables had improvement assessments of \$157,771 and \$159,557 or for \$46.69 and \$44.30 per square foot of living area, respectively. The subject's improvement assessment of \$170,407 or \$46.14 per square foot of living area falls above the two best comparables in this record on an overall basis and is bracketed by the two best comparables on a per square foot basis. However, after considering adjustments to the comparables for differences from the subject, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
