

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Roddy Loewenthal DOCKET NO.: 19-06222.001-R-1 PARCEL NO.: 16-34-105-047

The parties of record before the Property Tax Appeal Board are Roddy Loewenthal, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$75,046 **IMPR.:** \$127,834 **TOTAL:** \$202,880

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of brick exterior construction with 3,027 square feet of living area. The dwelling was built in 1977 and is 42 years old. Features of the home include a basement with a finished recreation room, central air conditioning, a fireplace and a 552 square foot attached garage. The property has a 20,146 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables located within the same assessment neighborhood code as the subject. The comparables are improved with one-story dwellings of brick, stucco, or wood siding exterior construction that range in size from 2,936 to 4,745 square feet of living area and are from 46 to 68 years old. The comparables have basements, with two having finished area. Other features of each comparable include central air conditioning, one or two fireplaces and an attached garage

ranging in size from 462 to 689 square feet of building area. The comparables have improvement assessments ranging from \$76,802 to \$179,466 or from \$26.16 to \$37.82 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$202,880. The subject has an improvement assessment of \$127,834 or \$42.23 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables located within the same assessment neighborhood code as the subject. The comparables are improved with one-story dwellings of wood siding, brick, or stone exterior construction that range in size from 2,987 to 3,234 square feet of living area and were built from 1976 to 1979. Each comparable has a basement with a recreation room, central air conditioning, one fireplace and an attached garage ranging in size from 460 to 552 square feet of building area. Comparables #2 and #4 have inground swimming pools. The comparables have improvement assessments ranging from \$118,480 to \$141,171 or from \$39.67 to \$44.53 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight equity comparables for the Board's consideration. The Board gave less weight to the appellant's comparables due to differences in age and/or dwelling size when compared to the subject. The Board also gave less weight to board of review comparables #2 and #4 which have inground swimming pools, not a feature of the subject.

The Board finds the best evidence of assessment equity to be board of review comparables #1 and #3. These comparables are similar to the subject in location, design, dwelling size, age and features. These comparables have improvement assessments of \$141,171 and \$133,167 or \$44.53 and \$41.18 per square foot of living area, respectively. The subject's improvement assessment of \$127,834 or \$42.23 per square foot of living area, falls below the two best comparables in this record on an overall basis and is bracketed on a square foot basis. Based on this evidence and after considering adjustments to the comparables for differences when compared to the subject, the Board finds the appellant did not prove by clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
