

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Mahesh Patel, the appellant, by attorney Robert Rosenfeld of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *no change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$52,752 **IMPR.:** \$137,904 **TOTAL:** \$190,656

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of brick exterior construction with 3,210 square feet of living area. The dwelling was constructed in 1981 and is approximately 38 years old. Features of the home include an unfinished basement, central air conditioning, a fireplace and a 500 square foot garage. The property has a 12,527 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables with the same assessment neighborhood code as the subject and located within .31 of a mile from the subject property. The comparables are improved with two-story dwellings of wood siding or brick exterior construction ranging in size from 2,308 to 3,414 square feet of living area. The dwellings range in age from 73 to 92 years old. The comparables each have a

basement, two of which have finished area. Each comparable has central air conditioning, one or two fireplaces and a garage ranging in size from 220 to 484 square feet of building area. The comparables have improvement assessments that range from \$90,066 to \$134,439 or from \$38.14 to \$39.38 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$124,949 or \$38.92 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$190,656. The subject property has an improvement assessment of \$137,904 or \$42.96 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on five equity comparables with the same assessment neighborhood code as the subject and located within .21 of a mile from the subject property. The board of review did not provide descriptive information for comparables #4 and #5, such as dwelling size, design, age and other features. Therefore, these two comparables will not be further addressed in this analysis. The board of review's comparables #1, #2 and #3 are improved with two-story dwellings of wood siding, brick or brick and wood siding exterior construction ranging in size from 2,934 to 3,132 square feet of living area. The dwellings were built from 1955 to 1997 with comparables #1 and #3 having reported effective ages of 1997 and 1980, respectively. Each comparable has a basement finished with a recreation room, central air conditioning and a garage ranging in size from 440 to 528 square feet of building area. Two comparables each have either one or two fireplaces. The comparables have improvement assessments that range from \$131,863 to \$211,062 or from \$44.94 to \$67.39 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of seven suggested equity comparables for the Board's consideration. The Board finds none of the comparables are truly similar to the subject due to significant differences in age, dwelling size and/or features. The Board has given less weight to the appellant's comparable #2 due to its considerably smaller dwelling size when compared to the subject. The Board finds the parties' remaining comparables are similar to the subject in location, dwelling size and design but have varying degrees of similarity to the subject in age and features. Nevertheless, these comparables have improvement assessments that range from \$117,336 to \$211,062 or from \$38.14 to \$67.39 per square foot of living area. The subject's improvement assessment of \$137,904 or \$42.96 per square foot of living area falls within the range established by the more similar comparables in the record both in terms of overall improvement assessment and on a square foot basis. Based on this record and after considering

adjustments to the comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
