



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Jennifer Blockinger

The parties of record before the Property Tax Appeal Board are Jennifer Blockinger, the appellant, by attorney Gregory Riggs, of Tax Appeals Lake County in Lake Zurich; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$58,637  
**IMPR.:** \$127,505  
**TOTAL:** \$186,142

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of wood siding construction with 3,132 square feet of living area. The dwelling was constructed in 1987. Features of the home include a full basement, central air conditioning, a fireplace, and a garage containing 598 square feet of building area. The property has an approximately 10,630 square foot site and is located in Libertyville, Libertyville Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales. The comparables are located in the same neighborhood code as the subject property and were constructed in 1987 or 1988. The comparables consist of two-story dwellings of brick or wood siding exterior construction ranging in size from 2,823 to 3,714 square feet of living area. Each dwelling has central air conditioning, one or two fireplaces, a full basement, and a garage ranging in size from 528 to 864 square feet

of building area. The parcels range in size from 9,980 to 13,190 square feet of land area. The comparables sold from January 2018 to July of 2019 for prices ranging from \$430,000 to \$610,000 or from \$144.18 to \$164.24 per square foot of living area, including land. The appellant requested the subject's assessment be reduced to \$171,316.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$186,142. The subject's assessment reflects a market value of \$565,953 or \$180.70 per square foot of living area, land included, when using the 2019 three year average median level of assessment for Lake County of 32.89% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales. Three of the four comparables are located in the same neighborhood code as the subject property. The comparables consist of two-story dwellings of brick, wood siding, or brick and wood siding exterior construction ranging in size from 2,841 to 3,127 square feet of living area. The dwellings were built from 1985 to 1988. Each dwelling has a full basement, central air conditioning, one or two fireplaces, and a garage ranging in size from 471 to 574 square feet of building area. The parcels range in size from 9,871 to 17,062 square feet of land area. The comparables sold in May 2019 and June 2019 for prices ranging from \$490,000 to \$653,500 or from \$172.47 to \$211.35 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of eight comparable sales to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to appellant's comparable #4 due to its dissimilar dwelling size when compared to the subject. The Board also gives reduced weight to board of review comparable #4 due to its location outside of the subject's neighborhood code.

The Board finds the best evidence of market value to be appellant's comparable sales #1 through #3 along with board of review comparable sales #1 through #3. The Board finds these comparables are more similar to the subject in location, dwelling size, design, age, and features. These most similar comparables sold for prices ranging from \$430,000 to \$653,500 or \$144.18 to \$211.35 per square foot of living area, including land. The subject's assessment reflects a market value of \$565,953 or \$180.70 per square foot of living area, including land, which is within the range established by the best comparable sales in this record. Based on this evidence and after considering adjustments to the best comparables for differences, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
