



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: North Tara LLC  
DOCKET NO.: 19-07299.001-R-1  
PARCEL NO.: 08-04-412-029

The parties of record before the Property Tax Appeal Board are North Tara LLC, the appellant, by Daiva Majauskas, of the Law Office of Daiva Majauskas in Downers Grove; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$2,830  
**IMPR.:** \$23,760  
**TOTAL:** \$26,590

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a condominium dwelling with 1,089 square feet of living area.<sup>1</sup> The dwelling was constructed in 1970. Features of the dwelling include central air conditioning and a 200 square foot patio. The property is located in Lisle, Lisle Township, DuPage County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales that are located within the same neighborhood code as the subject. The comparables are improved with condominium dwellings containing from 1,016 to 1,093 square feet of living area. The dwellings were built in 1970 and have central air conditioning. The comparables sold from June 2018 to April 2020 for prices ranging from \$40,000 to \$60,000 or from \$36.76 to \$59.05 per square foot of living area,

including land. The appellant's submission revealed the appellant's comparable #1 required repairs by HOA before issuance of an occupancy permit.

Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$26,590. The subject's assessment reflects a market value of \$80,600 or \$74.01 per square foot of living area, land included, when using the 2019 three-year average median level of assessment for DuPage County of 32.99% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on three comparable sales that are located within the same neighborhood code as the subject. The comparables are improved with condominium dwellings containing from 1,079 to 1,088 square feet of living area. The dwellings were built in 1970. Each comparable has central air conditioning and a 200 square foot deck or patio. The comparables sold from March 2018 to January 2019 for prices ranging from \$103,000 to \$105,000 or from \$95.28 to \$97.31 per square foot of living area, including land. The board of review's submission revealed the board of review's comparable #3 has subsequently sold in August 2020 for \$110,000.

Based on this evidence the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparable #1 due to its need for repairs at the time of its sale. The Board also gives less weight to the appellant's comparable #4, as well as the subsequent sale for the board of review's comparable #3, due to their sale dates occurring greater than 15 months after the January 1, 2019 assessment date at issue. The Board finds the parties' remaining comparables have varying degrees of similarity to the subject and also sold proximate in time to the January 1, 2019 assessment date at issue. The best comparables sold from March 2018 to September 2019 for prices ranging from \$45,000 to \$105,000 or from \$41.17 to \$97.31 per square foot of living area, including land. The subject's assessment reflects a market value of \$80,600 or \$74.01 per square foot of living area, including land, which falls within the range established by the best comparable sales in the record. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported. Based on this evidence the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
