



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Raymond Wunderlick

The parties of record before the Property Tax Appeal Board are Raymond Wunderlick, the appellant, by attorney Robert Rosenfeld of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$38,108
IMPR.: \$150,747
TOTAL: \$188,855

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 3,444 square feet of living area. The dwelling was constructed in 1999 and is approximately 20 years old. Features of the home include a basement finished with a 1,109 square foot recreation room, central air conditioning, a fireplace and a 484 square foot garage. The property has a 7,840 square foot site and is located in Vernon Hills, Vernon Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables with the same assessment neighborhood code as the subject and located within .16 of a mile from the subject property. The comparables are improved with two-story dwellings of wood siding exterior construction with 3,444 or 3,476 square feet of living area. The dwellings range in age from 19 to 21 years old. Each comparable has an unfinished basement, central air

conditioning and a 484 square foot garage. Comparable #1 has one fireplace. The comparables have improvement assessments that range from \$141,135 to \$142,188 or from \$40.80 to \$40.98 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$140,919 or \$40.92 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$188,855. The subject property has an improvement assessment of \$150,747 or \$43.77 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on five equity comparables with the same assessment neighborhood code as the subject and located within .13 of a mile from the subject property. The board of review's comparable #5 is a duplicate of the appellant's comparable #3. The comparables are improved with two-story dwellings of wood siding exterior construction, each with 3,444 square feet of living area. The dwellings were built in 1998 or 2000. The comparables each have a basement, one of which has a recreation room with 793 square feet of finished area. Each comparable has central air conditioning and a garage with either 484 or 704 square feet of building area. Two comparables each have one fireplace and comparable #2 has a hot tub. The comparables have improvement assessments that range from \$141,135 to \$152,233 or from \$40.98 to \$44.20 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of eight suggested equity comparables for the Board's consideration, as one comparable was common to both parties. The Board finds all of the comparables are similar, if not identical to the subject in dwelling size, design, age and some features. However, the board finds seven of the eight comparables have no basement recreation room and five of the comparables have no fireplace, both of which are features of the subject, suggesting upward adjustments for these features would be required to make the comparables more equivalent to the subject. The comparables have improvement assessments that range from \$141,135 to \$152,233 or from \$40.80 to \$44.20 per square foot of living area. The subject's improvement assessment of \$150,747 or \$43.77 per square foot of living area falls within the range established by the best comparables in the record and is particularly supported by board of review comparable #3, which is the only comparable in the record with a basement recreation room like the subject. Based on this record and after considering adjustments to the comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
