

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Svetlana Pyasik DOCKET NO.: 19-07454.001-R-1 PARCEL NO.: 14-28-208-005

The parties of record before the Property Tax Appeal Board are Svetlana Pyasik, the appellant, by attorney Robert Rosenfeld of Robert H. Rosenfeld and Associates, LLC in Chicago, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *no change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$26,814 **IMPR.:** \$131,681 **TOTAL:** \$158,495

Subject only to the State multiplier as applicable.

## **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property is improved with a two-story dwelling of wood siding exterior construction containing 2,788 square feet of living area. The dwelling was built in 1991. Features of the home include an unfinished full basement with 1,494 square feet, central air conditioning, one fireplace and an attached garage with 440 square feet of building area. The property has a 10,050 square foot site and is located in Lake Zurich, Ela Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables improved with two-story dwellings of frame construction ranging in size from 2,437 to 2,788 square feet of living area. The dwellings were built from 1989 to 1991. Three comparables have unfinished basements with either 709 or 721 square feet. Each comparable has central air conditioning, one fireplace, and an attached garage with either 420 or 440 square

feet of building area. The comparables have the same assessment neighborhood code as the subject property and are located from approximately .05 to .35 of a-mile from the subject property. The improvement assessments on these properties range from \$108,017 to \$123,522 or from \$44.30 to \$44.74 per square foot of living area. The appellant requested the subject's improvement assessment be reduced to \$123,982.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$158,495. The subject property has an improvement assessment of \$131,681 or \$47.23 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on five equity comparables improved with two-story dwellings of wood siding exterior construction with either 2,788 or 2,883 square feet of living area. The homes were built in 1992 or 1993. Each comparable has a full unfinished basement with either 1494 or 1,581 square feet, central air conditioning, one or two fireplaces, and an attached garage with either 420 or 440 square feet of building area. The comparables have the same assessment neighborhood code as the subject property and are located from approximately .15 to .26 of a-mile from the subject property. The improvement assessments on these properties range from \$134,794 to \$142,487 or from \$48.35 to \$49.55 per square foot of living area.

### **Conclusion of Law**

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted information on nine comparables to support their respective positions. The comparables submitted by the parties are similar to the subject in location, style and age. The Board finds, however, the board of review comparables are more like the subject dwelling in dwelling size and features, especially with reference to the basement area, than are the comparables provided by the appellant; therefore, the Board gives more weight to the board of review comparables. The board of review comparables have improvement assessments that range from \$134,794 to \$142,487 or from \$48.35 to \$49.55 per square foot of living area. The subject's improvement assessment of \$131,681 or \$47.23 per square foot of living area falls below the range established by the best comparables in this record.

Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
