

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Michael Schlesinger, the appellant, by attorney Robert Rosenfeld of Robert H. Rosenfeld and Associates, LLC, in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds<u>*No Change*</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$ 79,183
IMPR.:	\$144,382
TOTAL:	\$223,565

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of brick construction that has 3,411 square feet of living area. The dwelling was built in 1957 with an effective age of 1973. Features include an unfinished basement, central air conditioning, a fireplace and an attached 1,410 square foot garage. The subject property is located in Vernon Township, Lake County.

The appellant contends assessment inequity as the basis of the appeal. The subject's land assessment was not challenged. In support of the inequity claim, the appellant submitted a grid analysis of four assessment comparables located from .43 to 1.47 miles from the subject. The comparables consist of one-story dwellings of wood siding exterior construction that are from 52 to 64 years old. The comparables have an unfinished basement, central air conditioning, two or three fireplaces and an attached garage that range in size from 588 to 667 square feet of building area. The dwellings range in size from 2,531 to 3,245 square feet of living area.

comparables have improvement assessments ranging from \$100,698 to \$127,305 or from \$38.87 to \$39.79 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's final assessment of \$223,565. The subject property has an improvement assessment of \$144,382 or \$42.33 per square foot of living area. In support of the subject's assessment, the board of review submitted three assessment comparables located from .08 to 1.06 miles from the subject. The comparables consist of one-story dwellings of brick or frame construction that were built from 1964 to 1979. One comparable has partial unfinished basement and two comparables have basements that are partially finished. Other features include central air conditioning, two fireplaces and attached garages that contain from 520 to 600 square feet of building area. Comparable #2 has a tennis court. The dwellings range in size from 3,126 to 3,725 square feet of living area. The comparables have improvement assessments ranging from \$132,307 to \$159,326 or from \$42.32 to \$44.42 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer argued assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof.

The record contains seven assessment comparables for the Board's consideration. The Board gave less weight to comparables #3 and #4 submitted by the appellant due to their smaller dwelling size when compared to the subject. Additionally, comparable #4 is not in close proximity being located 1.47 miles from the subject. The Board gave less weight to comparables #3 submitted by the board of review due to its distant location of 1.06 miles from the subject. The Board finds the three remaining comparables are more similar when compared to the subject in location, design, age, dwelling size and most features, however, these properties have a smaller garage and one comparable has a partial finished basement and tennis court when compared to the subject, requiring an upward and downward adjustments to make them more equivalent to the subject. These comparables have improvement assessments ranging from \$123,647 to \$144,528 or from \$38.87 to \$44.42 per square foot of living area. The subject property has an improvement assessment of \$144,382 or \$42.33 per square foot of living area, which falls within the range established by the most similar assessment comparables contained in this record on a per square foot basis. After considering adjustments to the comparables for differences when compared to the subject, the Board finds the subject's improvement assessment is supported. Therefore, no reduction in the subject's improvement assessment is warranted.

The constitutional provision for uniformity of taxation and valuation does not require mathematical equality. The requirement is satisfied if the intent is evident to adjust the burden

with a reasonable degree of uniformity and if such is the effect of the statute enacted by the General Assembly establishing the method of assessing real property in its general operation. A practical uniformity, rather than an absolute one, is the test. <u>Apex Motor Fuel Co. v. Barrett</u>, 20 Ill.2d 395 (1960). Although the comparables presented disclosed that properties located in the same area are not assessed at identical levels, all that the constitution requires is a practical uniformity which appears to exist on the basis of the evidence.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
