

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Inga Sapalaite, the appellant; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$2,830
IMPR.:	\$23,760
TOTAL:	\$26,590

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a condominium unit of brick exterior construction with 1,083 square feet of living area. The dwelling was constructed in 1970 and features central air conditioning. The property is located in Lisle, Lisle Township, DuPage County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted a grid analysis along with Multiple Listing Service (MLS) sheets and a purchase contract with information on four comparable sales located within 0.10 of a mile from the subject property. The comparables are improved with condominium units of brick/vinyl exterior construction that range in size from 1,016 to 1,093 square feet of living area. The dwellings were each built in 1970 and feature central air conditioning. The properties sold from June 2018 to April 2020 for prices ranging from \$40,000 to \$60,000 or from \$36.76 to \$59.05 per square foot of living area, land included.

The MLS sheets depict the appellant's comparable #1 as sold at auction and being a bank owned property at the time of sale and comparable #3 reported "rental sold as is." The purchase contract for the appellant's comparable #4 reported the property was sold in "as is" condition. Based on this evidence, the appellant requested the subject's assessment be reduced to \$15,000 which reflects a market value of \$45,005 or \$41.56 per square foot of living area, land included, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$26,590. The subject's assessment reflects a market value of \$80,600 or \$74.42 per square foot of living area, land included, when using the 2019 three-year average median level of assessment for DuPage County of 32.99% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted a grid analysis, a map depicting the proximity of both parties' comparables to the subject and PTAX-203 Illinois Real Estate Transfer Declarations with information on three comparable sales located within close proximity to the subject property. The comparables are improved with condominium units of brick exterior construction that range in size from 1,079 to 1,088 square feet of living area. The homes were each built in 1970 and feature central air conditioning. The properties sold from March 2018 to January 2019 for prices ranging from \$103,000 to \$105,000 or from \$95.28 to \$97.31 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales, or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted seven comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparable #4 which sold in April 2020, less proximate in time to the January 1, 2019 assessment date than other properties in the record.

The Board finds the best evidence of market value to be the remaining comparables which sold more proximate to the assessment date at issue and are similar to the subject in location, age, design, dwelling size and features. These comparables sold from March 2018 to September 2019 for prices ranging from \$40,000 to \$105,000 or from \$36.76 to \$97.31 per square foot of living area, including land. The subject's assessment reflects a market value of \$80,600 or \$74.42 per square foot of living area, including land, which falls within the range established by the best comparable sales in this record. After considering appropriate adjustments to the comparables for differences from the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
