

## FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Polly Reese, the appellant, by attorney Eric Feldman of Eric Feldman & Assoc. P.C. in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$56,320
IMPR.:	\$126,245
TOTAL:	\$182,565

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of brick and wood siding exterior construction with 2,534 square feet of living area. The dwelling was constructed in 1984. Features of the home include a concrete slab foundation, central air conditioning, a fireplace and a 440 square foot garage. The property is located in Highland Park, West Deerfield Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on four comparable sales with the same assessment neighborhood code as the subject and located within .36 of a mile from the subject property. The comparables are improved with two-story dwellings of wood siding or brick and wood siding exterior construction ranging in size from 2,236 to 2,451 square feet of living area. The dwellings were built in 1977 or 1978. The appellant reported that one comparable has a partial

basement finished with a recreation and three comparables have concrete slab foundations. Each comparable has central air conditioning, a fireplace and a garage ranging in size from 462 to 529 square feet of building area. The properties sold from October 2018 to August 2019 for prices ranging from \$330,000 to \$440,000 or from \$146.02 to \$179.52 per square foot of living area, including land. The appellant provided a "Redfin" computer printout associated with the sale of the appellant's comparable #2 indicating the property sold on August 2, 2019 for a price of \$440,000.

The appellant reported in Section III – Description of Property of the appeal petition that the subject property was purchased in July 2017 for a price of 645,000 or 254.54 per square foot of living area, including land.

Based on this evidence, the appellant requested the subject's assessment be reduced to \$135,187, which would reflect a market value of \$405,602 or \$160.06 per square foot of living area, including land, when using the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$182,565. The subject's assessment reflects a market value of \$555,078 or \$219.05 per square foot of living area, land included, when using the 2019 threeyear average median level of assessment for Lake County of 32.89% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on three comparable sales with the same assessment neighborhood code as the subject and located within .33 of a mile from the subject property. The comparables are improved with twostory dwellings of brick or brick and wood siding exterior construction ranging in size from 2,325 to 2,746 square feet of living area. The dwellings were built from 1977 to 1984. The board of review reported that one comparable has a partial basement that is unfinished finished and two comparables have concrete slab foundations. Each comparable has central air conditioning, a fireplace and a garage ranging in size from 441 to 528 square feet of building area. The properties sold from May 2018 to June 2019 for prices ranging from \$546,000 to \$577,000 or from \$210.12 to \$243.01 per square foot of living area, including land. The board of review reported the subject had a sale date occurring in July 2017 for a price of \$645,000. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of seven suggested comparable sales for the Board's consideration. The Board has given less weight to the appellant's comparables #1 and #3, as well as board of

review comparable #2 due to differences from the subject in dwelling size and/or foundation type.

The board finds the best evidence of market value to be the parties' remaining comparables, which are relatively similar to the subject in location, dwelling size, design, foundation type, age and some features. These properties sold from September 2018 to August 2019 for prices ranging from \$423,000 to \$577,000 or from \$172.58 to \$243.01 per square foot of living area, including land. The subject's assessment reflects a market value of \$555,078 or \$219.05 per square foot of living area, including land, which falls within the range established by the best comparable sales in the record and well below the subject's 2017 purchase price of \$645,000. Based on this record and after considering adjustments to the comparables for differences when compared to the subject, the Board finds no reduction in the subject's estimated market value as reflected by its assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
