

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Bruce & Carrie Hilsgen

DOCKET NO.: 19-09291.001-R-1 PARCEL NO.: 18-10-109-028

The parties of record before the Property Tax Appeal Board are Bruce & Carrie Hilsgen, the appellants; and the LaSalle County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *no change* in the assessment of the property as established by the **LaSalle** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$7,417 **IMPR.:** \$42,173 **TOTAL:** \$49,590

Subject only to the State multiplier as applicable.

## **Statement of Jurisdiction**

The appellants timely filed the appeal from a decision of the LaSalle County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a one-story dwelling with vinyl exterior construction containing 1,652 square feet of living area. The dwelling was constructed in 2000. Features of the home include a fully finished partial basement, central air conditioning, a fireplace, an attached 2-car garage with 600 square feet of building area and two sheds. The property has a .29 of an acre or approximately 12,632 square foot site and is located in LaSalle, LaSalle Township, LaSalle County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument the appellants submitted information on three comparable sales that are located in LaSalle. The comparables have sites ranging in size from 9,600 to 11,288 square feet of land area that are improved with one-story dwellings containing from 1,426 to 1,714 square feet of living area. The dwellings were built from 1974 to 1978. The comparables have full basements, two of which have finished area, central air conditioning, a fireplace and a 1-car or a 2-car garage. The

comparables sold in October 2016 or June 2017 for prices ranging from \$128,000 to \$142,500 or from \$81.68 to \$90.42 per square foot of living area, including land.

Based on this evidence the appellants requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$49,590. The subject's assessment reflects a market value of \$148,473 or \$89.87 per square foot of living area, land included, when using the 2019 three-year average median level of assessment for LaSalle County of 33.40% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales that are located in LaSalle. The comparables have sites ranging in size from 4,792 to 10,890 square feet of land area that are improved with one-story dwellings containing from 1,140 to 1,691 square feet of living area. The dwellings were built from 1949 to 1988. The comparables have full or partial basements, two of which have finished area, central air conditioning and a garage ranging in size from 400 to 528 square feet of building area. Three comparables each have a fireplace. The comparables sold from September 2016 to August 2019 for prices ranging from \$147,000 to \$169,000 or from \$86.93 to \$148.25 per square foot of living area, including land.

Based on this evidence the board of review requested confirmation of the subject's assessment.

# **Conclusion of Law**

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven comparable sales for the Board's consideration. The Board gives less weight to the appellants' comparables, as well as the board of review's comparables #3 and #4, due to their sale dates occurring greater than 18 months prior to the January 1, 2019 assessment date at issue or their significantly smaller dwelling size, when compared to the subject. The Board finds the board of review's remaining comparables have varying degrees of similarity to the subject and also sold proximate to the January 1, 2019 assessment date at issue. However, each of the board of review's best comparables have smaller sites and older dwellings, when compared to the subject. Nevertheless, the best comparables sold in April and August 2019 for prices of \$157,900 and \$147,000 or \$118.54 and \$86.93 per square foot of living area, including land, respectively. The subject's assessment reflects a market value of \$148,473 or \$89.87 per square foot of living area, including land, which falls between the market values of the best comparables in the record. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported. Based on this evidence the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
