



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Acquisition 2017 LLC
DOCKET NO.: 19-22487.001-R-1

The parties of record before the Property Tax Appeal Board are Acquisition 2017 LLC, the appellant, by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$45,500
IMPR.: \$159,807
TOTAL: \$205,307

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame exterior construction with 5,231 square feet of living area. The dwelling is approximately 16 years old. Features of the home include a full basement with finished area, central air conditioning, five fireplaces and a 3.5-car garage. The property has a 26,000 square foot site and is located in Wilmette, New Trier Township, Cook County. The subject is classified as a class 2-09 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends contention of law¹ and improvement assessment inequity as the bases of the appeal. The subject's land assessment was not contested. In support of the improvement assessment inequity argument, the appellant submitted information on five equity comparables

that are located within the same neighborhood code as the subject. The comparables are improved with two-story dwellings of masonry or stucco exterior construction ranging in size from 5,057 to 5,234 square feet of living area. The dwellings range in age from 61 to 91 years old. Each comparable has a partial or a full basement with three having finished area. Each comparable has central air conditioning, two or three fireplaces, and a 2-car to a 4-car garage. The comparables have improvement assessments ranging from from \$99,237 to \$123,848 or from \$19.23 to \$23.91 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$116,703 or \$22.31 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$205,307. The subject property has an improvement assessment of \$159,807 or \$30.55 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on two equity comparables that are located within the same neighborhood code as the subject and two equity comparables that are located within a different neighborhood code as the subject. The comparables are improved with two-story dwellings of masonry exterior construction ranging in size from 5,254 to 5,395 square feet of living area. The dwellings range in age from 7 to 19 years old. Each comparable has a full basement with finished area, central air conditioning, three to five fireplaces and a 2-car or a 3-car garage. The comparables have improvement assessments ranging from \$162,927 to \$233,389 or from \$31.01 to \$44.37 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine comparable properties for the Board's consideration. The Board gave less weight to the appellant's comparables and the board of review's comparables #3 and #4 due to their considerably older ages and/or different neighborhood codes when compared to the subject.

The Board finds the best evidence of assessment equity to be the board of review comparables #1 and #2. The Board gave greater weight to these comparables as they are most similar to the subject in location, design, exterior construction, dwelling size, basement and features. These comparables have improvement assessments of \$162,927 or \$170,752 and \$31.01 or \$31.65 per square foot of living area. The subject's improvement assessment of \$159,807 or \$30.55 per square foot of living area falls below the assessments of the two best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and

convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
