

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Jacek Margosiak, the appellant(s), by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$8,625 **IMPR.:** \$18,318 **TOTAL:** \$26,943

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 34,500 square foot parcel of land improved with a 62-year-old, one-story, frame, single-family dwelling containing 1,283 square feet of building area. The property is located in Palos Park, Palos Township, Cook County and is classified as a class 2 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends inequity and overvaluation as the bases of the appeal. In support of the market value argument, the appellant submitted four sales comparables. The comparables are described as one-story, frame or masonry, single-family dwellings containing from 1,164 to 1,682 square feet of building area. These comparables sold from September 2016 to September 2018 for prices ranging from \$143.07 to \$214.78 per square foot of building area.

In support of the equity argument, the appellant submitted four equity comparables. These properties are described as one-story, frame or masonry, single-family dwellings. They range: in age from 54 to 63; in size from 1,131 to 1,574 square feet of building area; and in improvement assessment from \$11.05 to \$15.01 per square foot of building area.

The board of review submitted its "Board of Review Notes on Appeal." The subject's total assessment is \$37,672 with an improvement assessment of \$29,047 or \$22.64 per square foot of building area. The total assessment reflects a market value of \$376,720 or \$293.62 per square foot of building area using when using the level of assessment for class 2 property of 10% under the Cook County Real Property Assessment Classification Ordinance.

In support of the current assessment, the board of review submitted four comparables with sales information on one. The comparables are described as a one-story, frame or masonry, single-family dwellings. They range: in age from 62 to 76; in size from 1,072 to 1,425 square feet; and in improvement assessment from \$21.74 to \$27.29 per square foot of building area. Comparable #2 sold in August 2017 for \$298.51 per square foot of building area. The board of review also lists the sale of the subject in March 2016 for \$176.23 per square foot of building area.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c).

The Board finds the comparables best evidence of market value to be the appellant's comparables #1, #2, and #3. These properties sold from January to September 2018 for prices ranging from \$143.07 to \$214.78 per square foot of building area. The remaining were given less weight due to differences in sale date. In comparison, the subject's assessment reflects a market value of \$293.62 per square foot of building area which is above the range of these comparables and significantly above the slightly aged sale price. Therefore, the Board finds the appellant has proven by a preponderance of the evidence that the subject was overvalued, and a reduction is justified. After this reduction, the Board finds the subject is equitably assessed.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
