

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: North Shore Realty Management LLC

The parties of record before the Property Tax Appeal Board are North Shore Realty Management LLC, the appellant(s), by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,705 **IMPR.:** \$30,623 **TOTAL:** \$36,328

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of an owner-occupied, three-story, single-family dwelling of masonry construction with 1,630 square feet of living area. The dwelling was constructed in 2000. Features of the home include a slab foundation, central air conditioning, and a two-car garage. The property has a 1,937 square foot site and is located in Chicago, Rogers Park Township, Cook County. The subject is classified as a class 2-95 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity and contention of law as the basis of the appeal. The appellant did not submit a legal brief or any evidence to support the contention of law argument in support of the assessment inequity argument, the appellant submitted five equity comparables for consideration. The appellant did not report the exact proximity of the comparables relative to the subject but disclosed that two of them had the same neighborhood code as the subject. The

comparables were improved with either tow-story or three-story single-family residences of frame and masonry construction. The improvements ranged: in age from 16 to 46 years old; in size from 1,800 to 1,896 square feet of living area; and in improvement assessment from \$11.71 to \$14.23 per square foot of living area. Based on this evidence, the appellant requested an assessment of \$33,028.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$36,328. The subject property has an improvement assessment of \$30,623 or \$15.81 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables, all located on the subject's block. These comparables were improved with three-story, single-family residences of masonry construction. The improvements were all 19 years old, the same age as the subject, with 1,870 square feet of living area, and ranged in improvement assessment from \$16.10 to \$16.13 per square foot of living area.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity, and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant *did not meet* this burden of proof and a reduction in the subject's assessment *is not* warranted.

The Board finds the best evidence of assessment equity to be *board of comparables*. These comparables were given greater weight due to their proximity to the subject. These comparables had improvement assessments that ranged from \$16.10 to \$16.13 per square foot of living area. The subject's improvement assessment of \$15.81 per square foot of living area falls below the range established by the best comparables in this record. Based on this record the Board finds the appellant *did not* demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment *is not* justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
