

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Teco Properties Inc DOCKET NO.: 19-31720.001-R-1 PARCEL NO.: 08-14-401-138-0000

The parties of record before the Property Tax Appeal Board are Teco Properties Inc, the appellant, by attorney Herbert B. Rosenberg, of Rock Fusco & Connelly, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$1,866 **IMPR.:** \$49,272 **TOTAL:** \$51,138

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a three-story, six-unit, multi-family dwelling of masonry construction with 4,947 square feet of living area. The building is 43 years old. The property has a 2,871 square foot site and is located in Mt. Prospect, Elk Grove Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on 12 equity comparables, a corresponding brief with attached caselaw, a street map depicting the subject property's location in relation to the comparables properties and Google Map photos of the subject building and the comparable buildings. All of the comparables were improved with a six-unit, Class 2-11 development located in Mt. Prospect. The improvements ranged: in age between 41 and 46 years old; in size

between 5,001 and 6,210 square feet of living area; and in improvement assessment from \$6.81 to \$11.07 per square foot of living area. Based on this evidence, the appellant is requesting an assessment amount of \$45,795.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$70,173. The subject property has an improvement assessment of \$68,307 or \$13.81 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables; all contained sales data. All were improved with a two-story, multi-family dwelling of masonry construction with full basements with apartments. The improvements ranged in age: between 40 and 41 years old; in size between 4,670 and 4,935 square feet of living area; and in improvement assessments between \$11.23 to \$11.54 per square foot of living area.

In rebuttal, the appellant argued that the board of review's own suggested comparable properties supported the request for a reduction. The appellant reaffirmed the request for an assessment reduction.

## **Conclusion of Law**

The taxpayer asserts assessment inequity as the basis of the appeal. The Illinois Constitution requires that real estate taxes, "be levied uniformly by valuation ascertained as the General Assembly shall provide by law." Ill. Const. art. IX, §4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). This uniformity provision of the Illinois Constitution does not require absolute equality in taxation, however, and it is sufficient if the taxing authority achieves a reasonable degree of uniformity. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4<sup>th</sup> Dist. 2003).

When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e); Walsh, 181 Ill. 2d at 234 (1998). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof needed for a conviction of a crime. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did meet this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of assessment equity to be the appellant's comparables in the Victoria Hills Development (PINs ending in -014, -017 and -013). These comparables had the same improvement assessment of \$9.96 per square foot of living area. The subject's improvement assessment of \$13.76 per square foot of living area falls above the range established by the best comparables in this record. These comparables were given more weight based on their similarity in design, construction and size. It is worth noting, the subject property's assessed value is also above the range utilized by the board of review's own comparables. While the appellant cites to Pace Realty, this case is inapplicable here, as the

board of review's comparables were not derived from the same contested assessment. Pace Realty Group, Inc. v. The Property Tax Appeal Board, 306 Ill.App.3d 718 (2<sup>nd</sup> Dist. 1999) Regardless, based on this record the Board finds the appellant did demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
