



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are George Polymenakos, the appellant(s), by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$4,882  
**IMPR.:** \$10,157  
**TOTAL:** \$15,039

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

Appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a 5,358 square foot parcel of land improved with a 69-year-old, one-story, masonry, single-family dwelling, containing 1,379 square feet of living area. The property is located in Chicago, Hyde Park Township, Cook County and is a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

Appellant contends overvaluation as the basis of the appeal. In support of its overvaluation argument, appellant submitted sales information for four comparable properties that sold between April 2018 and October 2018 for prices ranging between \$59.02 to \$86.15 per square foot of living area, including land. The comparable sales properties were single-family dwellings of either masonry or masonry and frame construction and contained between 1,106 and 1,567 square feet of living area. In addition, appellant submitted a copy of a Judicial Sale Deed dated April 20, 2018, for the subject property. Appellant also submitted a copy of the board of

review's February 29, 2020, written decision reflecting an assessed valuation for the subject property of \$14,979. Based on this evidence, appellant requested a reduction in the subject property's assessment to \$9,279.

The board of review submitted its "Board of Review Notes on Appeal" depicting a total assessed valuation of \$14,979, with an improvement assessment of \$10,157. The subject's assessment reflects a market value of \$149,790, or \$108.62 per square foot of living area, including land, when applying the level of assessment for class 2 property of 10.00% under the Cook County Real Property Assessment Classification Ordinance. In support of the current assessment, the board of review submitted four sales comparable properties. The comparables were one-story, single-family dwellings, of masonry construction. They ranged in living area square footage between 1,092 and 1,177 and sold between March 2017 and August 2019 for prices ranging between \$131.69 and \$147.30 per square foot of living area, including land. In addition, the board of review included in its grid analysis that the subject property sold on July 19, 2018, for \$65,500, or \$47.50 per square foot of living area, including land.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of market value to be appellant's comparables #1, #3, and #4, and the board of review's sales comparables #1 and #2. These properties sold between 2017 and 2018 for prices ranging between \$59.02 to \$137.87 per square foot of living area, including land. They were most similar to the subject property in living area square footage and/or construction. Greater weight was also given to the comparable sales that were closest to the subject property in proximity. The subject's current assessment of \$108.62 per square foot of living area, including land, reflects a market value within the market value established by the best comparables in this record. Based on this record, the Board finds appellant has not proven, by a preponderance of the evidence, that the subject is overvalued, and that a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
