

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Jack & Steven Gore, the appellant(s), by attorney Joanne Elliott, of Elliott & Associates Attorneys, PLLC in Des Plaines; the Cook County Board of Review; the Palatine Twp. H.S.D. #211, and Schaumburg C.C.S.D. #54, intervenors, by attorney Michael J. Hernandez of Franczek P.C. in Chicago.

In a letter dated July 7, 2021, and received by the Board, intervenors Palatine Twp. H.S.D. #211 and Schaumburg C.C.S.D. #54 adopted and affirmed the evidence submitted by the board of review. The intervenors stated they would not file evidence. Prior to the hearing the appellant and the board of review reached an agreement as to the correct assessment of the subject property. This agreement was memorialized in a stipulation, dated December 18, 2023, submitted to the Board by the appellant and the board of review.

After reviewing the record and considering the evidence submitted, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this **Cook** County appeal. The Board finds the intervenors are precluded from withholding their authorization for settlement because they adopted the evidence submitted by the board of review. Consequently, the intervenors are bound by the terms of the settlement between the appellant and the board of review, memorialized by the stipulation by the appellant and the board of review. *See* 86 Ill.Admin.Code §1910.99(a).

The Property Tax Appeal Board further finds that the agreement of the parties is proper, and the correct assessed valuation of the property is:

LAND: \$414,331 **IMPR.:** \$243,333 **TOTAL:** \$657,664

Subject only to the State multiplier as applicable.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

Docket No: 19-44574.001-C-2

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
