

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Joseph Kurian DOCKET NO.: 20-00237.001-R-1 PARCEL NO.: 12-32-308-021

The parties of record before the Property Tax Appeal Board are Joseph Kurian, the appellant, by attorney Gregory Riggs, of Tax Appeals Lake County in Lake Zurich, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$78,962 **IMPR.:** \$146,900 **TOTAL:** \$225,862

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story dwelling of wood siding exterior construction with 3,108 square feet of living area. The dwelling was constructed in 1979. Features of the home include an unfinished basement, central air conditioning, three fireplaces and a 768 square foot garage. The property has a 38,770 square foot site and is located in Lake Forest, Shields Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on three comparable sales located from .58 to 1.03 miles from the subject. The comparables have sites ranging in size from 20,170 to 33,640 square feet of land area and are improved with 1.75-story or 2-story dwellings of brick or wood siding exterior construction that were built from 1968 to 1987. The dwellings range in size from 2,968 to 3,361 square feet of living area. The comparables have basements, one of which is finished with a

recreation room. Each comparable has central air conditioning, one or two fireplaces, and a garage ranging in size from 506 to 660 square feet of building area. The comparables sold from December 2019 to June 2020 for prices ranging from \$530,000 to \$657,500 or from \$178.57 to \$195.63 per square foot of living area, including land. The appellant noted the subject backs to major road. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$225,862. The subject's assessment reflects a market value of \$678,468 or \$218.30 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on six comparable sales located from .16 to 1.01 miles from the subject. The comparables have sites ranging in size from 21,800 to 49,120 square feet of land area and are improved with 2-story dwellings of brick or wood siding exterior construction that were built from 1957 to 1969. The dwellings range in size from 2,660 to 3,357 square feet of living area. The comparables have basements, three of which are finished with a recreation room. Each comparable has central air conditioning, one fireplace and a garage ranging in size from 506 to 759 square feet of building area. The comparables sold from April 2019 to October 2020 for prices ranging from \$615,000 to \$799,000 or from \$223.41 to \$266.96 per square foot of living area, including land.

# **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains nine suggested comparable sales for the Board's consideration. The Board gives less weight to appellant's comparable #1 along with board of review comparables #1, #2 and #3 which have finished basement area unlike the subject.

The Board finds the best evidence of the subject's market value to be the parties' remaining comparables which overall are more similar to the subject in location, dwelling size, age and features. These comparables sold from April 2019 to September 2020 for prices ranging from \$560,000 to \$685,000 or from \$185.19 to \$231.20 per square foot of living area, including land. The subject's assessment reflects a market value of \$678,468 or \$218.30 per square foot of living area, including land, which is within the range established by the best comparable sales in the record. Based on this evidence and after considering adjustments to the best comparable sales for differences when compared to the subject, the Board finds the subject's estimated market value reflected by the assessment is supported and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

# **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
