

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Eileen Schultz, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>*no change*</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$10,862
IMPR.:	\$92,245
TOTAL:	\$103,107

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of wood frame construction with 2,012 square feet of living area. The dwelling was constructed in 2001. Features of the home include a partially finished basement, central air conditioning and an attached 441 square foot garage. The property has a 11,330 square foot site and is located in Antioch, Antioch Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on five comparable sales that are located from .19 to .68 of a mile from the subject. The comparables have sites ranging in size from 12,458 to 19,166 square feet of land area that are improved with one-story dwellings containing from 1,724 to 2,348 square feet of living area. The dwellings were built from 2000 to 2017. The comparables have basements, two of which have finished area, central air conditioning and a garage ranging in size

from 484 to 792 square feet of building area. Three comparables each have a fireplace. The comparables sold from March 2019 to May 2020 for prices ranging from \$260,000 to \$367,500 or from \$150.81 to \$164.52 per square foot of living area, including land. Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$103,107. The subject's assessment reflects a market value of \$309,724 or \$153.94 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on three comparable sales that are located from .39 to .69 of a mile from the subject. The board of review's comparables #1, #2 and #3 are the same properties as the appellant's comparables #2, #5 and #4, respectively. The comparables have sites ranging in size from 12,460 to 14,810 square feet of land area that are improved with one-story dwellings containing from 1,941 to 2,000 square feet of living area. The dwellings were built from 2006 to 2017. The comparables have basements, two of which have finished area, central air conditioning and a garage ranging in size from 484 to 781 square feet of building area. One comparable has a fireplace. The comparables sold in March or June 2019 for prices ranging from \$309,000 to \$320,000 or from \$154.50 to \$164.52 per square foot of living area, including land. Based on this evidence the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of five comparable sales for the Board's consideration, three of which were submitted by both parties. The Board gives less weight to the appellant's comparables #1 and #3, due to their dissimilar dwelling size when compared to the subject. The Board finds the parties' common comparables have varying degrees of similarity to the subject. However, each of the best comparables is newer than the subject. Nevertheless, the best comparables sold in March or June 2019 for prices ranging from \$309,000 to \$320,000 or from \$154.50 to \$164.52 per square foot of living area, including land. The subject's assessment reflects a market value of \$309,724 or \$153.94 per square foot of living area, including land, which falls within the range established by the best comparable sales in the record on a total market value basis but below the range on a per square foot basis. However, after considering adjustments to the best comparables for differences when compared to the subject, such as their newer age, the Board finds the subject's lower per square foot estimated market value as reflected by its assessment is justified. Based on this evidence, the Board finds a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
