



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Mon Ami Realty, LLC

The parties of record before the Property Tax Appeal Board are Mon Ami Realty, LLC, the appellant, by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$8,971
IMPR.: \$35,442
TOTAL: \$44,413

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of wood siding exterior construction with 1,008 square feet of living area. The dwelling was constructed in 1952. Features of the home include a basement and a garage containing 440 square feet of building area. The property has an approximately 7,470 square foot site and is located in Lake Villa, Lake Villa Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales. The comparables are located in the same neighborhood code as the subject property and were built from 1933 to 1991. The comparables consist of one-story dwellings of wood siding exterior construction ranging in size from 600 to 1,744 square feet of living area. Three of the comparables have central air conditioning, three each have a fireplace, three each have a basement, and three have a garage

ranging in size from 480 to 1,200 square feet of building area. The parcels range in size from 8,740 to 18,640 square feet of land area. The comparables sold from March 2018 to August 2019 for prices ranging from \$60,000 to \$186,500 or from \$85.86 to \$115.98 per square foot of living area, including land. Based on this evidence, the appellant requested a reduced assessment of \$34,021.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$44,413. The subject's assessment reflects a market value of \$133,412 or \$132.35 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on five comparable sales. One of the comparables is located in the same neighborhood code as the subject property. The comparables consist of one-story dwellings of wood siding exterior construction ranging in size from 912 to 1,266 square feet of living area. The dwellings were built from 1952 to 1969. Three of the comparables have central air conditioning, three each have a fireplace, and four each have a basement with finished area. Each dwelling has a garage ranging in size from 200 to 1,200 square feet of building area. The parcels range in size from 4,600 to 87,750 square feet of land area. The comparables sold from July 2019 to September 2020 for prices ranging from \$145,000 to \$225,000 or from \$127.19 to \$218.20 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine comparable sales to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to appellant's comparables due to differences in dwelling size, age, foundation, and/or some features when compared to the subject. The Board also gives less weight to appellant comparable #3 due to its more remote sale date for valuation as of January 1, 2020. The Board gives reduced weight to board of review comparable #4 due to differences in foundation when compared to the subject.

The Board finds the best evidence of market value to be board of review comparable sales #1, #2, #3, and #5. These most similar comparables sold for prices ranging from \$175,000 to \$225,000 or from \$145.35 to \$218.20 per square foot of living area, including land. The subject's assessment reflects a market value of \$133,412 or \$132.35 per square foot of living area, including land, which is below the range established by the best comparable sales in this record. Based on this evidence, and after considering adjustments to the best comparables for differences, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
