

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Edward Angelbeck DOCKET NO.: 20-01056.001-R-1 PARCEL NO.: 16-09-112-005

The parties of record before the Property Tax Appeal Board are Edward Angelbeck, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$110,052 **IMPR.:** \$112,799 **TOTAL:** \$222,851

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of brick exterior construction with 2,740 square feet of living area. The dwelling was constructed in 1934 and is approximately 86 years old. Features of the home include a concrete slab foundation, central air conditioning, two fireplaces, and a detached 580-square foot garage. The property has an approximate 20,570 square foot site and is located in Lake Forest, West Deerfield Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located from .21 of a mile to 3.11 miles from the subject, one of which is also located in the same assessment neighborhood code as the subject. The appellant reported that the comparables consist of 1.8-story, 2-story or 2.5-story dwellings of brick or wood siding exterior construction that range in size from 2,493 to 3,150 square feet of living area. The dwellings

range in age from 72 to 95 years old. One comparable has a concrete slab foundation and three comparables each have a full or partial basement, two of which have finished area. Each comparable has central air conditioning. Three comparables have either one or four fireplaces. The appellant reported that two comparables each have an attached garage with either 357 or 440 square feet of building area, one comparable was reported as having "None/508", and one comparable was reported as having "Attached/0". The comparables have improvement assessments ranging from \$88,788 to \$115,148 or from \$34.19 to \$37.63 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced to \$97,818 or \$35.70 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$222,851. The subject property has an improvement assessment of \$112,799 or \$41.17 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on three equity comparables located in the same assessment neighborhood code as the subject and within .38 of a mile from the subject. The comparables consist of 1.75-story or 2-story dwellings of brick or wood siding exterior construction that range in size from 2,596 to 3,145 square feet of living area. The dwellings were built from 1927 to 1941. The comparables each have a full or partial basement, two of which have finished area. One comparable has central air conditioning. Each comparable has one or three fireplaces and an attached garage ranging in size from 420 to 600 square feet of building area. The comparables have improvement assessments ranging from \$120,497 to \$155,326 or from \$44.61 to \$49.39 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains seven suggested equity comparables for the Board's consideration. The Board gives less weight to the appellant's comparables #1, #3 and #4 as well as board of review comparable #2 due to their dissimilar locations or larger dwelling size when compared to the subject.

The Board finds the best evidence of assessment equity to be the parties' remaining comparables which are relatively similar to the subject in location, design, age and dwelling size with varying degrees of similarity in other features. These comparables have improvement assessments ranging from \$88,788 to \$126,920 or from \$35.12 to \$46.42 per square foot of living area. The subject's improvement assessment of \$112,799 or \$41.17 per square foot of living area falls within the range established by the best comparables in the record. Based on this record and after considering adjustments to the best comparables for differences when compared to the

subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
