

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Kevin Liebovich, the appellant, by attorney Robert Rosenfeld of Robert H. Rosenfeld and Associates, LLC in Chicago, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$175,171
IMPR.:	\$245,096
TOTAL:	\$420,267

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with two-story dwelling of brick exterior construction containing 5,477 square feet of living area. The dwelling was built in 1988 and is approximately 32 years old. Features of the home include an unfinished full basement, central air conditioning, three fireplaces and an attached garage with 832 square feet of building area. The property has a site with approximately 60,110 square feet of land area located in Lake Forest, West Deerfield Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables improved with two-story dwellings of brick exterior construction that range in size from 4,765 to 5,687 square feet of living area. The dwellings are 31 or 32 years old. Two comparables have slab foundations and one comparable has a partial basement that is partially

finished. Each property has central air conditioning, two or three fireplaces and an attached garage ranging in size from 736 to 892 square feet of building area. The comparables have the same assessment neighborhood code as the subject property and are located within approximately .21 of one mile from the subject property. The comparables have improvement assessments ranging from \$203,981 to \$242,347 or from \$39.52 to \$43.68 per square foot of living area. The appellant requested the subject's improvement assessment be reduced to \$229,668.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$420,267. The subject property has an improvement assessment of \$245,096 or \$44.75 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables improved with two-story dwellings of brick or brick and wood siding exterior construction that range in size from 4,904 to 5,438 square feet of living area. The homes were built from 1988 to 1991. Each property has a full or partial basement with three having finished area, central air conditioning, two fireplaces and an attached garage ranging in size from 748 to 966 square feet of building area. The comparables have the same assessment neighborhood code as the subject property and are located within .23 of one mile from the subject property. The comparables have improvement assessments that range from \$241,938 to \$268,067 or from \$44.75 to \$52.08 per square foot of living area.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be the comparables submitted by the board of review as these comparables are more similar to the subject dwelling in size and most features than are the comparables provided by the appellant. The comparables provided by the board of review are similar to the subject in features with the exception that three comparables have finished basement area while the subject has an unfinished basement, suggesting downward adjustments would be appropriate for this characteristic, and each comparable has one less fireplace than the subject, suggesting upward adjustments would be appropriate for this attribute. These comparables have improvement assessments that range from \$241,938 to \$268,067 or from \$44.75 to \$52.08 per square foot of living area. The subject's improvement assessment of \$245,096 or \$44.75 per square foot of living area falls within the range established by the best comparables in this record and is appropriate given the suggested adjustments. Less weight is given appellant's comparables #1 and #2 due to the fact each has a slab foundation while the subject has a full basement. Less weight is given appellant's comparable #3 as the dwelling is the least similar to the subject dwelling in size as it is approximately 13% smaller than the subject dwelling. Based on this record the Board finds the appellant did not demonstrate with

clear and convincing evidence that the subject's improvement was inequitably assessed. The Board finds the assessment of the subject property as established by the board of review is correct and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
