

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Tai Park

DOCKET NO.: 20-02439.001-R-1 PARCEL NO.: 15-28-211-015

The parties of record before the Property Tax Appeal Board are Tai Park, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$42,700 **IMPR.:** \$132,288 **TOTAL:** \$174,988

Subject only to the State multiplier as applicable.

## **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## **Findings of Fact**

The subject property consists of a 2-story dwelling of wood siding exterior construction with 2,279 square feet of living area. The dwelling was constructed in 1988. Features of the home include a basement, that has finished area, central air conditioning, 3.5 bathrooms, a fireplace, an attached 440 square foot garage and a gazebo. The property has an approximately 11,490 square foot site and is located in Buffalo Grove, Vernon Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables that are located from .33 to .52 of a mile from the subject. The comparables are improved with 2-story dwellings containing from 2,096 to 2,446 square feet of living area. The dwellings were built in 1985 or 1987. The comparables have basements, each of which have finished area, central air conditioning, 2.5 or 3.5 bathrooms, a fireplace and an attached 440 or

483 square foot garage. The comparables have improvement assessments ranging from \$105,011 to \$129,670 or from \$50.10 to \$54.67 per square foot of living area.

Based on this evidence the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$174,988. The subject property has an improvement assessment of \$132,288 or \$58.05 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on five equity comparables that are located from .11 to .54 of a mile from the subject. The comparables are improved with 2-story dwellings containing 2,220 or 2,279 square feet of living area. The dwellings were built from 1986 to 1989. The comparables have basements, each of which have finished area, central air conditioning, 2.5 bathrooms, one or two fireplaces and an attached 440 or 483 square foot garage. The comparables have improvement assessments ranging from \$121,687 to \$132,288 or from \$54.56 to \$58.05 per square foot of living area. The board of review highlighted the subject's greater number of bathroom fixtures, when compared to the board of review's comparables.

Based on this evidence the board of review requested confirmation of the subject's assessment.

## **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables for the Board's consideration. The Board finds each of the parties' comparables are similar to the subject in location, style, age and most features. However, the Board finds the best comparables in the record are the appellant's comparable #4, as well as the board of review's comparables #2 through #5, which are identical in size to the subject. However, each of the best comparables lack a gazebo, which is a feature of the subject and only the appellant's comparable #4 has the same number of bathrooms as the subject. Nevertheless, the best comparables have improvement assessments ranging from \$124,334 to \$132,288 or from \$54.56 to \$58.05 per square foot of living area. The subject's improvement assessment of \$132,288 or \$58.05 per square foot of living area is equal to the higher end of the range established by the best comparables in the record. After considering adjustments to the best comparables for differences when compared to the subject, such as their lack of a gazebo and smaller number of bathrooms, the Board finds the subject's improvement assessment is well justified and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
