



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Jacob Cox

The parties of record before the Property Tax Appeal Board are Jacob Cox, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 42,543
IMPR.: \$121,766
TOTAL: \$164,309

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 2,584 square feet of living area. The dwelling was constructed in 1971 and is approximately 49 years old. Features of the home include a full unfinished basement, central air conditioning, a fireplace and a 420 square foot garage. The property has an approximately 21,000 square foot site and is located in Barrington, Ela Township, Lake County.

The appellant contends assessment inequity as the basis of the appeal concerning the improvement assessment. In support of this argument, the appellant submitted information on four equity comparables located in the same assessment neighborhood code as the subject property and within .32 of a mile from the subject. The comparables consist of two-story dwellings of brick or wood siding exterior construction. The homes range in age from 49 to 54 years old and range in dwelling size from 2,616 to 2,796 square feet of living area. Each

comparable has a full unfinished basement, central air conditioning, one or two fireplaces and a garage ranging in size from 420 to 616 square feet of building area. The comparables have improvement assessments ranging from \$107,834 to \$125,944 or from \$41.22 to \$45.19 per square foot of living area.

Based on this evidence, the appellant requested a reduced improvement assessment of \$112,791 or \$43.65 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$164,309. The subject property has an improvement assessment of \$121,766 or \$47.12 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on five equity comparables located in the same assessment neighborhood code as the subject property and from .22 to .54 of a mile from the subject. The comparables consist of two-story dwellings of brick, wood siding or brick and wood siding exterior construction. The homes were built from 1969 to 1971 and range in dwelling size from 2,598 to 2,696 square feet of living area. Four of the comparables have full or partial unfinished basements and one comparable has a concrete slab foundation. Features include central air conditioning, a fireplace and a garage ranging in size from 484 to 616 square feet of building area. The comparables have improvement assessments ranging from \$124,970 to \$134,274 or from \$48.10 to \$50.88 per square foot of living area.

Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to appellant's comparables #2 and #3 along with board of review comparable #5 which are the largest dwellings presented in this record and thus are most dissimilar in dwelling size when compared to the subject dwelling. The Board has also given reduced weight to board of review comparable #2 which features a concrete slab foundation as compared to the subject's full unfinished basement.

The Board finds the best evidence of assessment equity to be appellant's comparables #1 and #4 along with board of review comparables #1, #3 and #4 which present varying degrees of similarity to the subject in location, age, dwelling size and features. These five comparables

have improvement assessments that range from \$107,834 to \$133,161 or from \$41.22 to \$50.46 per square foot of living area. The subject's improvement assessment of \$121,766 or \$47.12 per square foot of living area falls within the range established by the best comparables in this record and appears to be particularly well-supported by board of review comparable #1 that has many similarities with the subject dwelling. Based on this record and after considering appropriate adjustments to the best comparables in the record when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
