



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Maher Nahlawi

The parties of record before the Property Tax Appeal Board are Maher Nahlawi, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$69,984
IMPR.: \$316,743
TOTAL: \$386,727

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of brick exterior construction with approximately 6,171 square feet of living area.¹ The dwelling was built in 2005 and is approximately 15 years old. Features of the home include an unfinished full basement, central air conditioning, four fireplaces, and a 797 square foot attached garage. The property has an approximately 15,682 square feet of land area and is located in Vernon Hills, Libertyville Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables with the same assessment neighborhood code as the subject property and located

within 0.12 of a mile from the subject. The appellant reported that the comparables are improved with 2-story dwellings of brick or brick and frame exterior construction ranging in size from 4,660 to 5,166 square feet of living area. The dwellings are 15 to 17 years old. Each comparable has an unfinished basement, central air conditioning, one to three fireplaces, and a 711 to 921 square foot garage. The improvement assessments on these properties range from \$187,480 to \$241,114 or from \$40.23 to \$48.39 per square foot of living area. The appellant requested the subject's improvement assessment be reduced to \$279,249 or \$45.25 per square foot of living area, based on a dwelling size of 6,171 square feet.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$386,727. The subject property has an improvement assessment of \$316,743 or \$51.33 per square foot of living area, based on a dwelling size of 6,171 square feet. In support of its contention of the correct assessment, the board of review submitted information on five equity comparables with the same assessment neighborhood code as the subject property and located within 0.18 of a mile from the subject. The comparables are improved with 2-story dwellings of brick or brick and wood siding exterior construction ranging in size from 5,538 to 6,265 square feet of living area. The homes were built in 2004 or 2005. Each comparable has an unfinished full basement with three being walkout design, central air conditioning, two to four fireplaces, and an attached garage ranging in size from 795 to 1,247 square feet of building area. The improvement assessments on these properties range from \$282,922 to \$353,890 or from \$51.09 to \$56.49 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted information on nine comparables to support their respective positions. The Board gives less weight to the appellant's comparables which are improved with dwellings significantly smaller than the subject dwelling.

The Board finds the best evidence of assessment equity to be the board of review comparables which are more similar to the subject in location, design, age, dwelling size, and most features. These comparables have improvement assessments that range from \$282,922 to \$353,890 or from \$51.09 to \$56.49 per square foot of living area. The subject's improvement assessment of \$316,743 or \$51.33 per square foot of living area falls within the range established by the best comparables in this record. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
