

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Brian DiPaolo, the appellant, by attorney Ronald Kingsley of Lake County Real Estate Tax Appeal, LLC in Lake Forest, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$53,210
IMPR.:	\$118,958
TOTAL:	\$172,168

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction built in 1988 that contains 3,431 square feet of living area. Features of the home include a partial basement with a recreation room, central air conditioning, one fireplace and an attached garage with 800 square feet of building area. The property has a 58,810 square foot site located in Long Grove, Vernon Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales improved with two-story dwellings of brick or frame construction built in 1986 or 1987 that range in size from 2,789 to 4,028 square feet of living area. Each comparable has a basement with two having finished area, central air conditioning, one to three fireplaces and an attached garage ranging in size from 576 to 878 square feet of building area. Comparable #2 has an inground swimming pool. The comparables

are located from .25 to .60 of one mile from the subject property with sites ranging in size from 43,560 to 46,609 square feet of land area. The sales occurred from February 2018 to June 2020 for prices ranging from \$425,000 to \$550,000 or from \$124.15 to \$152.38 per square foot of living area, including land. The appellant requested the subject's total assessment be reduced to \$166,959.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$172,168. The subject's assessment reflects a market value of \$517,176 or \$150.74 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales improved with 1.5-story or 2-story dwellings of wood siding or brick and wood siding exterior construction that range in size from 3,171 to 3,576 square feet of living area. The homes were built from 1989 to 2004. Each comparable has a basement with two having finished area, central air conditioning, one to three fireplaces and an attached garage ranging in size from 576 to 962 square feet of building area. Comparable #3 has an inground swimming pool. The comparables have sites ranging in size from 9,140 to 57,660 square feet of land area and are located from approximately .34 to 1.25 miles from the subject property. The sales occurred from July 2019 to October 2020 for prices ranging from \$560,000 to \$615,000 or from \$158.64 to \$193.95 per square foot of living area, including land.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted information on eight comparable sales to support their respective positions. The Board gives little weight to appellant's comparable sales #1, #3 and #4 due to differences from the subject dwelling in size and/or the comparables did not sell proximate in time to the assessment date at issue. The Board gives little weight to board of review comparable #4 due to differences from the subject dwelling in age. The Board finds the best evidence of market value to be appellant's comparable sale #2 and board of review comparables #1 through #3 as these comparables are most similar to the subject dwelling in size and have varying degrees of similarity in features, location and land area. These four comparables sold for prices ranging from \$465,000 to \$604,900 or from \$126.63 to \$183.90 per square foot of living area, including land. The subject's assessment reflects a market value of \$517,176 or \$150.74 per square foot of living area, including land, which is within the range established by the best comparable sales in this record and well supported after considering possible adjustments to the comparables for differences from the subject property. Based on this evidence the Board finds the assessment of the subject property as established by the board of review is correct and a reduction in the subject's assessment is not justified.

The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
