

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Lisa Kennedy, the appellant, by attorney Eric Feldman of Eric Feldman & Assoc. P.C. in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$77,179
IMPR.:	\$91,138
TOTAL:	\$168,317

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of wood siding and brick exterior construction with 2,150 square feet of living area. The dwelling was constructed in 1975. Features of the home include a basement that is finished with a recreation room, central air conditioning, a fireplace and a 522 square foot garage. The property has a 10,450 square foot site and is located in Lake Bluff, Shields Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on five comparable sales with the same assessment neighborhood code as the subject and located within .50 of a mile from the subject property. The comparables have sites that range in size from 10,400 to 14,370 square feet of land area. The comparables are improved with 1.5-story or 2-story dwellings of brick, or wood siding and brick exterior construction ranging in size from 2,121 to 2,505 square feet of living area.

dwellings were built from 1962 to 1968. The comparables each have a basement, two of which are finished with a recreation room. Each comparable has central air conditioning, one fireplace and a garage ranging in size from 441 to 576 square feet of building area. The comparables sold from August 2018 to July 2020 for prices ranging from \$365,000 to \$536,000 or from \$159.74 to \$225.38 per square foot of living area, including land. Based on this evidence, the appellant requested the subject's assessment be reduced to \$137,925, which would reflect a market value of \$413,816 or \$192.47 per square foot of living area, including land, when using the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$168,317. The subject's assessment reflects a market value of \$505,608 or \$235.17 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on five comparable sales with the same assessment neighborhood code as the subject and located within .54 of a mile from the subject property. Board of review comparable #4 is the same property as the appellant's comparable #4. The comparables have sites that range in size from 10,400 to 13,250 square feet of land area. The comparables are improved with 1-story¹ or 2story dwellings of brick, wood siding, or wood siding and brick exterior construction ranging in size from 1,997 to 2,501 square feet of living area. The dwellings were built from 1962 to 1975. The comparables each have a basement, one of which is finished with a recreation room. Each comparable has central air conditioning, one fireplace and a garage ranging in size from 441 to 562 square feet of building area. The comparables sold from August 2018 to September 2020 for prices ranging from \$431,040 to \$577,500 or from \$215.84 to \$241.43 per square foot of living area, including land.

The board of review indicated its course of action is to offer to reduce the subject's total assessment to \$158,318, reflecting the median of the county comparables and the appellant's comparable #4.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains nine suggested comparable sales for the Board's consideration, as one sale was common to both parties. The Board has given less weight to the appellant's comparables #1 and #3, along with board of review comparable #2 due to their larger dwelling sizes when

¹ The board of review's comparable #2 has a ground floor area of 880 square feet with an above ground area of 2,501 square feet, suggesting this is a part two-story dwelling.

compared to the subject. The Board has also given less weight to the appellant's comparable #4/board of review comparable #4 due to the sale date occurring in 2018, less proximate in time to the assessment date at issue than the other comparable sales in the record.

The Board finds the best evidence of market value to be the parties' remaining comparables. The Board finds these five comparables are similar to the subject in location, dwelling size, age and some features, except all five comparables have less finished basement area, if any, when compared to the subject, suggesting upward adjustments would be required to make the comparables more equivalent to the subject. The comparables sold from January 2019 to September 2020 for prices ranging from \$365,000 to \$577,500 or from \$159.74 to \$241.43 per square foot of living area, including land. The subject's assessment reflects a market value of \$505,608 or \$235.17 per square foot of living area, including land, which falls within the range established by the best comparable sales in the record. Based on this record and after considering adjustments to the best comparables for differences when compared to the subject, the Board finds no reduction in the subject's estimated market value as reflected by its assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
