



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Eric Doveala

The parties of record before the Property Tax Appeal Board are Eric Doveala, the appellant, by attorney Eric Feldman, of Eric Feldman & Assoc. P.C. in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$12,434
IMPR.: \$87,556
TOTAL: \$99,990

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of vinyl siding exterior construction with 2,720 square feet of living area. The dwelling was constructed in 1994. Features of the home include a basement with 1,065 square feet of finished area, central air conditioning, a fireplace, and a 441 square foot garage. The property has an approximately 10,830 square foot site and is located in Grayslake, Avon Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on five comparable sales located within 0.51 of a mile from the subject. The parcels range in size from 8,750 to 12,560 square feet of land area. The comparables are improved with 2-story homes of vinyl siding exterior construction ranging in size from 2,276 to 3,090 square feet of living area. The dwellings were built from 1994 to 1998. Each home features a basement, one of which has 117 square feet of finished area, central air

conditioning, and a garage ranging in size from 400 to 642 square feet of building area. Three homes each have a fireplace. The comparables sold from January 2019 to May 2020 for prices ranging from \$225,000 to \$240,000 or from \$74.07 to \$98.86 square feet of living area, including land.

Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$99,990. The subject's assessment reflects a market value of \$300,360 or \$110.43 per square foot of living area, land included, when using the 2020 three year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on five comparable sales located within 0.59 of a mile from the subject. The parcels range in size from 8,500 to 10,580 square feet of land area and are improved with 2-story homes of vinyl siding exterior construction ranging in size from 2,422 to 2,732 square feet of living area. The dwellings were built from 1992 to 1995. Each home has a basement, three of which have from 378 to 665 square feet of finished area, central air conditioning, and a garage ranging in size from 378 to 639 square feet of building area. Four homes each have a fireplace. The comparables sold from June 2018 to November 2020 for prices ranging from \$304,500 to \$333,000 or from \$120.74 to \$129.06 per square foot of living area, including land.

Based on this evidence the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of ten comparable sales for the Board's consideration. The Board gives less weight to the board of review's comparable #1, which sold less proximate in time to the assessment date than other comparables in this record. The Board also gives less weight to the appellant's comparables and the board of review's comparable #3, which are less similar to the subject in dwelling size than other comparables in this record.

The Board finds the best evidence of market value to be the board of review's comparables #2, #4, and #5, which are more similar to the subject in dwelling size, age, location, and features, although two of these comparables lack finished basement area which is a feature of the subject, suggesting upward adjustments to these comparables would be needed to make them more equivalent to the subject. These most similar comparables sold from June 2019 to November 2020 for prices ranging from \$304,500 to \$325,500 or from \$120.74 to \$129.06 per square foot of living area, including land. The subject's assessment reflects a market value of \$300,360 or

\$110.43 per square foot of living area, including land, which is below the range established by the best comparable sales in this record. Based on this evidence and after considering appropriate adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
