

## FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are USA University Mentor LLC, the appellant, by attorney Eric Feldman, of Eric Feldman & Assoc. P.C. in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$4,626
IMPR.:	\$28,797
TOTAL:	\$33,423

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story dwelling of vinyl siding exterior construction with 1,037 square feet of living area. The dwelling was built in 1973. Features of the home include a full basement with finished area and central air conditioning. The property has an approximately 1,584 square feet of land area and is located in Grayslake, Avon Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on four comparable sales with the same assessment neighborhood code as the subject property and located within 0.12 of a mile from the subject. The comparables have sites with either 1,540 or 1,550 square feet of land area. The appellant reported that the comparables are improved with 2-story dwellings of vinyl siding exterior construction with either 1,037 or 1,260 square feet of living area. The dwellings were each built in 1973. Three comparables each have a finished basement and one comparable has a concrete

slab foundation. Each comparable has central air conditioning. One comparable has one fireplace. Three comparables each have a 299 square foot attached garage. The properties sold from January 2019 to January 2020 for prices ranging from \$56,700 to \$87,400 or from \$54.68 to \$69.37 per square foot of living area, land included.

Based on this evidence, the appellant requested the subject's assessment be reduced to \$22,392, which would reflect a market value of \$67,183 or \$64.79 per square foot of living area, including land, when using the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$33,423 reflecting a market value of \$100,400 or \$96.82 per square foot of living area, including land, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of the subject's assessment, the board of review submitted information on five comparable sales with the same assessment neighborhood code as the subject property and located within 0.32 of a mile from the subject. The comparables have sites that range in size from 1,530 to 1,710 square feet of land area. The board of review reported that the comparables are improved with 2-story dwellings of vinyl siding exterior construction with either 1,037 or 1,071 square feet of living area. The dwellings were each built in 1973. Each comparable has a full basement with three having finished area and central air conditioning. Two comparables each have one fireplace. Four comparables each have a 299 square foot detached garage. The properties sold from June 2019 to December 2020 for prices ranging from \$118,000 to \$127,000 or from \$111.95 to \$122.47 per square foot of living area, land included. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains nine comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparables #1, #2, and #4 which differ from the subject in dwelling size and/or lacks a basement, a feature of the subject.

The Board finds the best evidence of market value to be the parties' remaining comparables which are identical or nearly identical to the subject in age, dwelling size, and most features. However, five of these comparables have a garage and three comparables have one fireplace, not features of the subject, suggesting downward adjustments for these differences would be required to make them more equivalent to the subject. Nevertheless, these properties sold from June 2019 to December 2020 for prices ranging from \$56,700 to \$127,000 or from \$54.68 to \$122.47 per square foot of living area, land included. The subject's assessment reflects an estimated market value of \$100,400 or \$96.82 per square foot of living area, land included,

which falls within the range established by the best comparable sales in the record. Based on the record and after considering adjustments to the best comparables for differences from the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
