

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Yuval Malka, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$45,341
IMPR.:	\$129,408
TOTAL:	\$174,749

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story dwelling of brick exterior construction with 2,968 square feet of living area. The dwelling was constructed in 1966. Features of the home include a basement with finished area, central air conditioning, a fireplace and a 576 square foot garage. The property has an approximate 21,340 square foot site and is located in Lincolnshire, Vernon Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales located within 0.49 of a mile from the subject property. The comparables have sites with 20,038 or 20,473 square feet of land area and are improved with 2-story dwellings of brick and frame exterior construction that range in size from 2,440 to 2,789 square feet of living area. The dwellings were built in either 1969 or 1972. Each comparable has a basement with finished area, central air conditioning, one fireplace and a

garage ranging in size from 484 to 600 square feet of building area. The properties sold from August 2019 to July 2020 for prices ranging from \$180,000 to \$487,000 or from \$64.54 to \$186.59 per square foot of living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$158,278 which reflects a market value of \$474,881 or \$160.00 per square foot of living area, land included, when applying the statutory assessment level of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$174,749. The subject's assessment reflects a market value of \$524,929 or \$176.86 per square foot of living area, land included, when using the 2020 three year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on five comparable sales located within 0.45 of a mile from the subject property. The comparables have sites that range in size from 20,040 to 26,140 square feet of land area and are improved with 1.5-story or 2-story dwellings of brick or wood siding exterior construction that range in size from 2,730 to 3,314 square feet of living area. The homes were built from 1963 to 1980. Each comparable has a basement, three with finished area, central air conditioning, one fireplace and a garage ranging in size from 506 to 575 square feet of building area. Comparable #1 also features an inground swimming pool. The properties sold from July 2019 to October 2020 for prices ranging from \$532,500 to \$750,000 or from \$191.13 to \$274.73 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

## **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine comparable sales for the Board's consideration. The Board gives less weight to appellant comparable #1 which differs from the subject in dwelling size. The Board gives reduced weight to appellant comparable #3 which appears to be an outlier based on its sale price and price per square foot in contrast to other comparable sales in the record. The Board also gives less weight to board of review comparables #1, #2 and #5 which feature an inground swimming pool, unfinished basement and/or differ in age when compared to the subject's age, finished basement and lack of inground pool feature.

The Board finds the best evidence of market value to be the remaining comparables which are more similar to the subject in location, age, dwelling size and features. These comparables sold from August 2019 to October 2020 for prices ranging from \$460,000 to \$710,000 or from \$171.39 to \$244.41 per square foot of living area, including land. The subject's assessment reflects a market value of \$524,929 or \$176.86 per square foot of living area, including land,

which falls within the range established by the best comparable sales in this record. After considering adjustments to the comparables for differences from the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
