



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Alan Dattel

The parties of record before the Property Tax Appeal Board are Alan Dattel, the appellant, by attorney Eric Feldman of Eric Feldman & Assoc. P.C. in Chicago, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$45,376
IMPR.: \$134,337
TOTAL: \$179,713

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a two-story dwelling of wood siding exterior construction built in 1989 that contains 2,996 square feet of living area. Features of the home include a full basement with a recreation room, central air conditioning, one fireplace and an attached garage with 441 square feet of building area. The property has a 12,230 square foot site located in Buffalo Grove, Vernon Township, Lake County.

In support of this argument the appellant submitted information on three comparable sales improved with two-story dwellings of wood siding exterior construction that range in size from 2,873 to 3,384 square feet of living area. The homes were built from 1988 to 1991. Each comparable has an unfinished full basement, central air conditioning, and an attached garage with either 441 or 704 square feet of building area. Two comparables have one or two fireplaces. These properties have sites ranging in size from 13,580 to 29,290 square feet of land

area and are located from approximately .04 to .61 of one mile from the subject property. The sales occurred from March 2019 to December 2019 for prices ranging from \$450,000 to \$545,000 or from \$147.75 to \$180.64 per square foot of living area, including land. The appellant requested the total assessment be reduced to \$162,268.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$179,713. The subject's assessment reflects a market value of \$539,841 or \$180.19 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on five comparable sales with comparable #3 being the same property as appellant's comparable #3. The comparables are improved with two-story dwellings of wood siding exterior construction that range in size from 2,873 to 3,017 square feet of living area. The homes were constructed from 1988 to 1991. Each comparable has a full basement with two having finished area, central air conditioning, and an attached garage ranging in size from 441 to 693 square feet of building area. Four comparables each have one fireplace and comparable #1 has an inground swimming pool. These properties have sites ranging in size from 10,790 to 23,460 square feet of land area and are located from approximately .13 to .61 of one mile from the subject property. The sales occurred from March 2019 to November 2020 for prices ranging from \$525,000 to \$619,000 or from \$174.65 to \$208.91 per square foot of living area, including land.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains seven comparable sales submitted by the parties to support their respective positions with one comparable sale being common to the parties. The Board gives less weight to appellant's comparable sale #2 as this comparable is improved with a dwelling less similar to the subject dwelling in size than the remaining sales in the record. The Board gives less weight to board of review comparable #1 as this property has an inground swimming pool, a feature the subject property does not have. The Board gives most weight to appellant's comparable sales #1 and #3 and board of review comparables #2 through #5, which includes the common sale. Three of the comparables have unfinished basements, unlike the subject's basement recreation room, suggesting each would require an upward adjustment to make them more equivalent to the subject property. These comparables sold for prices ranging from \$450,000 to \$550,000 or from \$156.63 to \$185.62 per square foot of living area, including land. The subject's assessment reflects a market value of \$539,841 or \$180.19 per square foot of living area, including land, which is within the range established by the best comparable sales in this record and well supported after considering the suggested adjustments to the comparables. Based on this

evidence the Board finds the assessment of the subject property as established by the board of review is correct and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
