

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Ajay Madhani, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$41,735
IMPR.:	\$156,444
TOTAL:	\$198,179

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of brick exterior construction with 3,701 square feet of living area. The dwelling was constructed in 1998. Features of the home include an unfinished basement, central air conditioning, a fireplace and a 630 square foot garage. The property has an approximately 14,990 square foot site and is located in Vernon Hills, Libertyville Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on five comparable sales located within 0.35 of a mile from the subject property. The comparables have sites that range in size from 9,375 to 13,339 square feet of land area and are improved with two-story dwellings of brick and frame exterior construction that range in size from 3,163 to 3,610 square feet of living area. The dwellings were built from 1997 to 1999. Each comparable has an unfinished basement, central air conditioning, one or two

fireplaces and a garage ranging in size from 440 to 649 square feet of building area. The properties sold from May 2019 to May 2020 for prices ranging from \$460,000 to \$550,000 or from \$144.04 to \$167.02 per square foot of living area, land included.

The appellant also submitted a copy of the Multiple Listing Service sheet for its comparable #5 which disclosed the property had been "rehabbed in 2017." Based on this evidence, the appellant requested the subject's total assessment be reduced to \$176,397 which reflects a market value of \$529,244 or \$143.00 per square foot of living area, land included, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$198,179. The subject's assessment reflects a market value of \$595,311 or \$160.85 per square foot of living area, land included, when using the 2020 threeyear average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales located within 0.34 of a mile from the subject property. The comparables have sites that range in size from 9,900 to 13,360 square feet of land area and are improved with two-story dwellings of brick exterior construction that range in size from 3,219 to 3,666 square feet of living area. The homes were built in 1998 or 1999. Each comparable has an unfinished basement, one or two fireplaces and a garage with either 440 or 649 square feet of building area. Three dwellings each have central air conditioning. The properties sold from January 2018 to December 2020 for prices ranging from \$533,000 to \$610,000 or from \$160.49 to \$179.18 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales, or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine comparable sales for the Board's consideration. The Board gives less weight to appellant comparables #2, #3, #4 and #5 which differ from the subject in dwelling size and/or site size. The Board gives less weight to board of review comparables #2, #3 and #4 which sold in 2018, less proximate in time to the January 1, 2020 assessment date than other properties in the record.

The Board finds the best evidence of market value to be appellant comparable #1 and board of review comparable #1 which sold more proximate in time to the assessment date at issue and are more similar to the subject in location, age, design, dwelling size and other features. These two comparables sold in October 2019 and December 2020 for prices of \$520,000 and \$610,000 or \$144.04 and \$166.39 per square foot of living area, including land. The subject's assessment

reflects a market value of \$595,311 or \$160.85 per square foot of living area, including land, which is bracketed by the two best comparable sales in this record. After considering appropriate adjustments to the comparables for differences from the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
