

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Reed Hoekstra, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>*no change*</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$180,147
IMPR.:	\$181,549
TOTAL:	\$361,696

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of wood siding exterior construction with 3,652 square feet of living area. The dwelling was constructed in 1964. Features of the home include a basement, that has finished area, central air conditioning, two fireplaces and an attached 504 square foot garage. The property has a 37,030 square foot site and is located in Lake Forest, Shields Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales that are located from .10 to .80 of a mile from the subject. The comparables have sites ranging in size from 43,900 to 60,984 square feet of land area that are improved with 1-story or 2-story dwellings ranging in size from 3,258 to 3,918 square feet of living area. The dwellings were built from 1963 to 1985, with a hoime built in 1968 having a 1975 effective age. The comparables have basements, two of which have

finished area, central air conditioning, from one to three fireplaces, and a garage ranging in size from 504 to 667 square feet of building area. The comparables sold from April 2018 to July 2020 for prices ranging from \$775,000 to \$1,300,000 or from \$237.88 to \$334.02 per square foot of living area, including land.

Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$361,696. The subject's assessment reflects a market value of \$1,086,500 or \$297.51 per square foot of living area, land included, when using the 2020 threeyear average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales that are located from .54 of a mile to 2.87 miles from the subject. The board of review's comparables #2 and #3 are the same properties as the appellant's comparables #2 and #1, respectively. The comparables have sites ranging in size from 20,050 to 48,790 square feet of land area that are improved with 1.5-story, 1.75-story or 2-story dwellings of wood siding or brick exterior construction ranging in size from 3,056 to 3,970 square feet of living area. The dwellings were built from 1964 to 1985, with effective ages ranging from 1975 to 1987. The comparables have basements, three of which have finished area, central air conditioning, two, three or five fireplaces, and an attached or detached garage ranging in size from 484 to 750 square feet of building area. The comparables sold from March 2019 to November 2020 for prices ranging from \$1,047,500 to \$1,300,000 or from \$267.36 to \$368.13 per square foot of living area, including land.

Based on this evidence the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of six comparable sales for the Board's consideration, two of which were submitted by both parties. The Board gives less weight to the appellant's comparable #4 due to its sale date occurring greater than 20 months prior to the January 1, 2020 assessment date at issue. The Board also gives less weight to the board of review's comparable #1 due to its location over 2.50 miles from the subject. The Board finds the parties' remaining comparables, which includes the parties' common comparables, have varying degrees of similarity to the subject. The best comparables sold from March 2019 to July 2020 for prices ranging from \$775,000 to \$1,300,000 or from \$237.88 to \$334.02 per square foot of living area, including land. The subject's assessment reflects a market value of \$1,086,500 or \$297.51 per square foot of living area, including land, which falls within the range established by the best comparables in

the record. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
