

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Tammy Mayer DOCKET NO.: 20-04556.001-R-1 PARCEL NO.: 14-12-305-020

The parties of record before the Property Tax Appeal Board are Tammy Mayer, the appellant, by attorney Eric Feldman, of Eric Feldman & Assoc. P.C. in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$39,897 **IMPR.:** \$121,754 **TOTAL:** \$161,651

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story dwelling of brick exterior construction with 3,245 square feet of living area. The dwelling was constructed in 1987. Features of the home include an unfinished full basement, central air conditioning, one fireplace, and a 792 square foot garage. The property has an approximately 79,610 square foot site and is located in Hawthorn Woods, Ela Township, Lake County.<sup>1</sup>

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on five comparable sales with the same assessment

neighborhood code as the subject property and located within 0.53 of a mile from the subject. The comparables have sites that range in size from 39,860 to 112,780 square feet of land area. The appellant reported that the comparables are improved with 2-story dwellings of brick, wood siding, or brick and wood siding exterior construction ranging in size from 2,274 to 3,714 square feet of living area. The dwellings were built from 1983 to 1989. Each comparable has an unfinished basement, central air conditioning, one or two fireplaces, and a 704 to 1,464 square foot garage. The properties sold from August 2019 to July 2020 for prices ranging from \$325,000 to \$530,000 or from \$118.53 to \$146.88 per square foot of living area, including land.

Based on this evidence, the appellant requested an assessment reduction.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$161,651. The subject's assessment reflects a market value of \$485,584 or \$149.64 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on four comparable sales with the same assessment neighborhood code as the subject property and located within 0.23 of a mile from the subject. The comparables have sites that range in size from 39,140 to 43,610 square feet of land area. The comparable are improved with 2-story dwellings of wood siding or wood and brick exterior construction ranging in size from 2,787 to 3,357 square feet of living area. The dwellings were built from 1985 to 1988 with comparable #1 having an effective year built of 1988. Each comparable has an unfinished full basement, central air conditioning, one or two fireplaces, and a 483 to 900 square foot garage. Comparable #1 has an inground swimming pool. The properties sold from March 2019 to November 2020 for prices ranging from \$445,000 to \$610,000 or from \$156.74 to \$185.50 per square foot of living area, including land. Based on this evidence, the board of review requested the subject's assessment be sustained.

#### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains nine suggested comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparable #5 and board of review comparable #1 which differs from the subject in dwelling size or has an inground swimming pool, which is not a feature of the subject.

The Board finds the best evidence of market value to be the parties' remaining comparables which are overall more similar to the subject in location, design, age, dwelling size, and most features. These properties sold from March 2019 to November 2020 for prices ranging from \$410,000 to \$530,000 or from \$118.53 to \$185.50 per square foot of living area, including land. The subject's assessment reflects a market value of \$485,584 or \$149.64 per square foot of living area, including land, which falls within the range established by the best comparable sales in the record. Based on the record and after considering adjustments to the best comparables for differences from the subject, the Board finds a reduction in the subject's estimated market value as reflected by its assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
