

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are John Huelskamp, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$44,395
IMPR.:	\$148,484
TOTAL:	\$192,879

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of wood siding exterior construction with 3,269 square feet of living area. The dwelling was constructed in 1985 and has an effective age of 1992. Features of the home include a basement, central air conditioning, two fireplaces, and a 644 square foot garage. The property has a 44,394 square foot site and is located in Barrington, Ela Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on seven comparable sales presented in two grid analyses.¹ The comparables are located within 0.70 of a mile from the subject. The parcels range in size from 10,219 to 45,410 square feet of land area and are improved with 2-story homes of frame or brick and frame exterior construction ranging in size from 2,872 to 3,773 square feet of living area.

¹ One grid analysis has five comparables and a second grid analyses has two additional comparables.

The dwellings were built from 1976 to 1989 with the oldest home having an effective age of 1979. The appellant reported that comparables #2 and #5 were recently rehabbed and that comparables #4 and #5 each have a better quality grade than the subject. Each home has a basement, central air conditioning, one to three fireplaces, and a garage ranging in size from 616 to 756 square feet of building area. The comparables sold from June 2019 to April 2020 for prices ranging from \$470,000 to \$586,600 or from \$134.38 to \$172.35 per square foot of living area, including land. Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$192,879. The subject's assessment reflects a market value of \$579,390 or \$177.24 per square foot of living area, land included, when using the 2020 three year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on three comparable sales located within 0.81 of a mile from the subject. The parcels range in size from 48,530 to 51,500 square feet of land area and are improved with 1.5-story or 2-story homes of wood siding exterior construction ranging in size from 3,018 to 3,568 square feet of living area. The dwellings were built in 1984 or 1987. Each home has a basement, one of which is a walkout basement, central air conditioning, one or two fireplaces, and a garage ranging in size from 682 to 864 square feet of building area. The comparables sold from July 2019 to July 2020 for prices ranging from \$650,000 to \$735,000 or from \$182.17 to \$243.54 per square foot of living area, including land.

The board of review also submitted a listing sheet for the subject property, which describes an April 2021 sale of the subject for \$725,000 or \$221.78 per square foot of living area, including land.

Based on this evidence the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of ten comparable sales and evidence of a recent sale of the subject property. The Board gives less weight to the April 2021 sale of the subject, which is approximately 16 months prior to the January 1, 2020 assessment date and less likely to be indicative of market value as of that date. The Board also gives less weight to the appellant's comparables #1, #4, #5, and #7, due to substantial differences from the subject in dwelling size, lot size, and/or age.

The Board finds the best evidence of market value to be the appellant's comparables #2, #3, and #6 and the board of review's comparables, which are similar to the subject in dwelling size, age, location, lot size, and most features. These most similar comparables sold from July 2019 to July 2020 for prices ranging from \$493,000 to \$735,000 or from \$159.34 to \$243.54 per square foot of living area, including land. The subject's assessment reflects a market value of \$579,390 or \$177.24 per square foot of living area, including land, which is within the range established by the best comparable sales in this record. Based on this evidence and after considering appropriate adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
