

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Rebecca Solano, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>*A Reduction*</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$6,220
IMPR.:	\$50,482
TOTAL:	\$56,702

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story duplex dwelling of brick exterior construction with 2,866 square feet of living area. The dwelling was built in 1929. Features of the home include an unfinished basement, one fireplace, and a garage with 400 square feet of building area. The property has an approximately 7,100 square foot site and is located in Waukegan, Waukegan Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on four comparable sales located within 0.53 of a mile from the subject. The comparables have sites that range in size from 6,473 to 8,952 square feet of land area. The comparables are improved with 1.5-story or 2-story dwellings ranging in size from 2,560 to 3,186 square feet of living area. The dwellings were built from 1930 to 1964. Each comparable was reported to have an unfinished basement and three comparables each have one

fireplace and a garage ranging in size from 342 to 475 square feet of building area. The properties sold from January 2019 to February 2020 for prices ranging from \$142,000 to \$184,900 or from \$47.08 to \$61.55 per square foot of living area, land included. Based on this evidence, the appellant requested an assessment reduction to \$49,195 which reflects a market value of \$147,600 or \$51.50 per square foot of living area, land included, when using the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$64,540. The subject's assessment reflects a market value of \$193,872 or \$67.65 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on three comparable sales with the same assessment neighborhood code as the subject property and located within 0.36 of a mile from the subject. The comparables have sites that range in size from 6,000 to 12,970 square feet of land area. The comparables are improved with 1-story or 2-story duplex dwellings of brick or aluminum siding exterior construction ranging in size from 2,018 to 2,560 square feet of living area. The dwellings were built from 1930 to 1964. Each comparable has an unfinished basement; one comparable has central air conditioning and two fireplaces; and two comparables each have garages where comparable #1 has two garages of 506 and 720 square feet of building area and comparable #3 has a 440 square foot garage. The properties sold from December 2019 to December 2020 for prices ranging from \$195,000 to \$235,000 or from \$77.73 to \$116.45 square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be sustained.

## **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The record contains seven suggested comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparable #2 which differs from the subject in age and lacks a garage, a feature of the subject. The Board gives less weight to the board of review comparables which differ from the subject in age and/or dwelling size.

The Board finds the best evidence of market value to be the appellant's comparables #1, #3, and #4 which are overall more similar to the subject in location, age, dwelling size, and most features. The properties sold in January and March 2019 for prices ranging from \$147,000 to \$184,900 or from \$47.08 to \$61.55 per square foot of living area, land included. The subject's assessment reflects a market value of \$193,872 or \$67.65 per square foot of living area, land includes, which falls above the range established by the best comparable sales in the record and is excessive. Based on the record and after considering adjustments to the best comparables for

differences from the subject, the Board finds a reduction in the subject's estimated market value as reflected by its assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
