

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Joel Saltzman, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$1,714 **IMPR.:** \$52,554 **TOTAL:** \$54,268

Subject only to the State multiplier as applicable.

## **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story condominium unit of vinyl siding exterior construction with 1,696 square feet of living area. The dwelling was built in 2005. Features of the home include an unfinished basement, central air conditioning, and a garage with 400 square feet of building area. The property is located in Round Lake, Avon Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on five comparable sales located within 0.16 of a mile from the subject. The comparables are improved with 2-story dwellings with 1,696 square feet of living area. The dwellings were built from 2003 to 2005. Each comparable is reported to have an unfinished basement, central air conditioning, and a garage with 400 square feet of building area. Two comparables each have one fireplace. The properties sold from January 2018 to June 2020

for prices ranging from \$146,500 to \$161,500 or from \$86.38 to \$95.22 per square foot of living area, land included. Based on this evidence, the appellant requested an assessment reduction.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$54,268. The subject's assessment reflects a market value of \$163,016 or \$96.12 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on five comparable sales located within 0.18 of a mile from the subject. The comparables are improved with 2-story condominium units of vinyl siding exterior construction with 1,696 square feet of living area. The dwellings were built in 2003 or 2005. One comparable has a basement with finished area and three comparables each have a slab foundation. Each comparable has central air conditioning, and a garage with 400 square feet of building area. One comparable has one fireplace. The properties sold from June 2019 to November 2020 for prices ranging from \$162,000 to \$178,000 or from \$95.52 to \$104.95 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be sustained.

## **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains ten suggested comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparables #1, #3, #4, and #5 which have sale dates greater than 17 months prior to the subject's lien date and thus sold less proximate in time to the subject's assessment date than the other comparables in the record.

The Board finds the best evidence of market value to be the parties' remaining comparables which sold more proximate in time to the subject's assessment date. These comparables are identical to the subject in dwelling size and similar to the subject in location, age, and most amenities. However, four of the board of review comparables lack a basement, a feature of the subject, suggesting upward adjustments for this difference are required to make them more equivalent to the subject. Additionally, one board of review comparable has basement finish, unlike the subject, suggesting a downward adjustment is required for this difference to make it more equivalent to the subject. Nevertheless, the properties sold from June 2019 to November 2020 for prices ranging from \$152,000 to \$178,000 or from \$89.62 to \$104.95 per square foot of living area, land included. The subject's assessment reflects a market value of \$163,016 or \$96.12 per square foot of living area, land included, which falls within the range established by the best comparables sales in the record. Based on the record and after considering adjustments to the best comparables for differences from the subject, the Board finds a reduction in the subject's estimated market value as reflected by its assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
