



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Andrew D'Amore, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$20,013  
**IMPR.:** \$172,268  
**TOTAL:** \$192,281

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of wood siding exterior construction with 4,410 square feet of living area. The dwelling was constructed in 2003. Features of the home include a full basement with a 1,732 square foot recreation room, central air conditioning, two fireplaces and a 696 square foot garage. The property has an 18,010 square foot site and is located in Gurnee, Warren Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted a brief along with information on five comparable sales located from .21 of a mile to 1.63 miles from the subject. The parcels range in size from 11,761 to 20,473 square feet of land area and are each improved with a two-story dwelling of wood frame exterior construction. The homes were built from 1996 to 2003 and range in size from 3,562 to 3,973 square feet of living area. Each comparable has a basement, central air conditioning, a fireplace

and a garage ranging in size from 476 to 994 square feet of building area. The appellant's brief asserts several of the comparables have lower land market values. The comparables sold from May to December 2019 for prices ranging from \$402,000 to \$598,000 or from \$101.18 to \$154.04 per square foot of living area, including land.

Based on this evidence, the appellant requested a reduced total assessment of \$176,382 which would reflect a market value of \$529,199 or \$120.00 per square foot of living area, including land, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$192,281. The subject's assessment reflects a market value of \$577,594 or \$130.97 per square foot of living area, land included, when using the 2020 three year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on four comparable sales located from .61 of a mile to 2.01 miles from the subject. The parcels range in size from 41,000 to 64,470 square feet of land area and are each improved with a two-story dwelling of wood siding exterior construction. The homes were built from 2000 to 2005 and range in size from 3,844 to 4,398 square feet of living area. Each comparable has a basement, one of which has a recreation room. Each dwelling has central air conditioning, one or three fireplaces and a garage ranging in size from 704 to 844 square feet of building area. The comparables sold from October 2020 to January 2021 for prices ranging from \$580,000 to \$630,000 or from \$143.25 to \$159.99 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine comparable sales with varying degrees of similarity to the subject for the Board's consideration. The comparables sold from May 2019 to January 2021 for prices ranging from \$402,000 to \$630,000 or from \$101.18 to \$159.99 per square foot of living area, including land. The subject's assessment reflects a market value of \$577,594 or \$130.97 per square foot of living area, including land, which is within the range established by the best comparable sales in this record both in terms of overall value and on a per-square-foot basis. Based on this evidence and after considering necessary adjustments to the comparable sales for differences when compared to the subject property, the Board finds the appellant failed to establish overvaluation by a preponderance of the evidence and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
