

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Magdalena Slota DOCKET NO.: 20-05722.001-R-1 PARCEL NO.: 16-27-113-013

The parties of record before the Property Tax Appeal Board are Magdalena Slota, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$44,610 **IMPR.:** \$115,535 **TOTAL:** \$160,145

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

# **Findings of Fact**

The subject property consists of a 2-story dwelling of brick exterior construction with 2,369 square feet of living area. The dwelling was constructed in 1948 with an effective year built of 1983 due to remodeling in 2005. Features of the home include a basement with finished area, central air conditioning, one fireplace and a 440 square foot garage. The property has an approximately 7,280 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on three comparable sales located within .50 of a mile from the subject. The comparables have sites ranging in size from 10,001 to 12,689 square feet of land area and are improved with 2-story dwellings ranging in size from 2,512 to 2,791 square feet of living area. The dwellings were constructed in 1968 or 1977. The comparables each have a

basement, central air conditioning, one fireplace and a garage ranging in size from 396 to 462 square feet of building area. The comparables sold from July 2018 to July 2020 for prices ranging from \$410,000 to \$470,000 or from \$158.00 to \$168.40 per square foot of living area, land included. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$160,145. The subject's assessment reflects a market value of \$481,060 or \$203.06 per square foot of living area, land included, when using the 2020 three year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on five comparable sales located within .76 of a mile from the subject. The properties have sites ranging in size from 7,300 to 20,180 square feet of land area and are improved with 1.5-story or 2-story dwellings of wood siding or brick exterior construction. The dwellings range in size from 2,100 to 2,672 square feet of living area and were built from 1938 to 1978 with comparables #1, #2 and #3 having effective years built of 1994, 1974 and 1985, respectively. Four comparables have basements, three of which have finished area. One comparable has a lower level with finished area. Each comparable has central air conditioning and a garage ranging in size from 260 to 552 square feet of building area. One comparable has a fireplace. The comparables sold from April 2019 to September 2020 for prices ranging from \$480,000 to \$797,000 or from \$222.22 to \$325.04 per square foot of living area, land included. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

#### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparables and board of review comparable #4 which are newer dwellings when compared to the subject. The Board gives less weight to board of review comparable #3 which is a dissimilar 1.5-story dwelling with a finished lower level unlike the subject which is a 2-story dwelling with a basement.

The Board finds the best evidence of market value to be board of review comparables #1, #2 and #5 which overall are more similar to the subject in location, age, dwelling size and features. These comparables sold from April 2019 to March 2020 for prices ranging from \$480,000 to \$675,000 or from \$222.22 to \$252.62 per square foot of living area, including land. The subject's assessment reflects a market value of \$481,060 or \$203.06 per square foot of living area, including land, which is within the range established by the best comparable sales on overall value and below on price per square foot. After considering adjustments to the best

comparables for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported. Based on this evidence, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

# **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
