



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Keri Alberts

The parties of record before the Property Tax Appeal Board are Keri Alberts, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$89,649
IMPR.: \$143,661
TOTAL: \$233,310

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of Dryvit exterior construction with 2,800 square feet of living area. The dwelling was constructed in 1994. Features of the home include a basement with finished area, central air conditioning, one fireplace, and a 546 square foot garage. The property has an approximately 10,870 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales located from .15 to 1.28 miles from the subject. The comparables have sites ranging in size from 12,023 to 15,442 square feet of land area and were improved with 2-story dwellings that were built from 1941 to 1988 with comparable #3 having an effective year built of 1964. The dwellings range in size from 2,632 to 3,117 square feet of living area. The comparables each have a basement, central air conditioning,

one fireplace and a garage ranging in size from 420 to 600 square feet of building area. The comparables sold from June 2019 to April 2020 for prices ranging from \$460,000 to \$700,000 or from \$174.77 to \$255.78 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$233,310. The subject's assessment reflects a market value of \$700,841 or \$250.30 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for Lake County of 33.29% as determined by the Illinois Department of Revenue. In support of its contention of the correct assessment, the board of review submitted information on five comparable sales located within .98 of a mile from the subject. The comparables have sites ranging in size from 7,810 to 19,500 square feet of land area and were improved with 2-story dwellings of brick, wood siding, stucco, brick and wood siding, or stone and wood siding exterior construction that were built from 1925 to 1999 with comparables #2, #4, and #5 having effective years built of 1981, 1976 and 1971, respectively. The dwellings range in size from 2,646 to 3,204 square feet of living area. Features of each comparable include a basement with four having finished area. Each comparable has central air conditioning, one fireplace, and a garage ranging in size from 391 to 660 square feet of building area. The comparables sold from July 2019 to October 2020 for prices ranging from \$755,000 to \$855,000 from \$259.20 to \$291.01 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The record contains nine suggested comparable sales for the Board's consideration. The Board gives less weight to appellant's comparables #1, #2 and #3 along with board of review comparables #1, #2, #4 and #5 due to significant differences in year built when compared to the subject. The Board finds the best evidence of market value to be appellant's comparable #4 and board of review comparable #3 which are most similar to the subject in year built and relatively similar to the subject in location, land size, dwelling size, and some features. However, appellant's comparable #4 lacks finished basement area which suggests an upward adjustment is necessary to make it more equivalent to the subject. The comparables sold in September and August 2019 for prices of \$675,000 and \$810,000 or for \$255.78 and \$259.20 per square foot of living area, including land. The subject's assessment reflects a market value of \$700,841 or \$250.30 per square foot of living area, including land, which is bracketed by the two best comparable sales on overall value and falls below on price per square foot. Therefore, after considering adjustments to the best comparable sales for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by the assessment is supported and no reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
