

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Peter Liosatos, the appellant, by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>*A Reduction*</u> in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$49,210
IMPR.:	\$140,940
TOTAL:	\$190,150

Subject only to the State multiplier as applicable.

## **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## **Findings of Fact**

The subject property consists of a two-story dwelling of brick and frame exterior construction with 4,047 square feet of living area. The dwelling was constructed in 1989. Features of the home include a basement, central air conditioning, a fireplace, and a 704 square foot garage. The property has an 8,400 square foot site and is located in Addison, Addison Township, DuPage County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales, together with a listing sheet for each comparable sale. The parcels range in size from 5,960 to 12,319 square feet of land area and are improved with two-story homes of brick or brick and frame exterior construction<sup>1</sup> ranging in size

from 3,520 to 4,695 square feet of living area. The dwellings were built from 1988 to 2007. Each home has a basement, two of which have finished area,<sup>2</sup> central air conditioning, a fireplace, and a garage ranging in size from 585 to 808 square feet of building area. Comparable #2 has an inground swimming pool and a hot tub. The comparables sold from June 2017 to October 2019 for prices ranging from \$440,000 to \$520,000 or from \$109.69 to \$125.00 per square foot of living area, including land.

As part of the appeal, the appellant also disclosed that the subject property is an owner-occupied residence. The Board further takes judicial notice that this property was the subject matter of an appeal before the Property Tax Appeal Board the prior year under Docket Number 19-008866.001-R-1. In that appeal the Property Tax Appeal Board issued a decision lowering the assessment of the subject property to \$182,840 based on the evidence submitted by the parties.

Based on this evidence the appellants requested a reduction in the subject's assessment to \$160,758 which would reflect a market value of \$482,322 or \$119.18 per square foot of living area, including land, at the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$201,780. The subject's assessment reflects a market value of \$604,132 or \$149.28 per square foot of living area, land included, when using the 2020 three year average median level of assessment for DuPage County of 33.40% as determined by the Illinois Department of Revenue.

Also, as part of the "Board of Review Notes on Appeal," the board of review reported that 2019 was the first year of the general assessment cycle for the subject property and that for tax year 2020 an equalization factor of 1.0400 was applied to non-farm properties in Addison Township.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales, together with a map depicting the locations of both parties' comparables in relation to the subject and property record cards for the parties' comparables. The four comparable sales are located within the same assessment neighborhood code as the subject property. The parcels range in size from 8,400 to 18,130 square feet of land area and are improved with two-story homes of brick or brick and frame exterior construction ranging in size from 3,334 to 5,208 square feet of living area. The dwellings were built in 1989. Each home has a basement, one of which has finished area, central air conditioning, one to three fireplaces, and a garage ranging in size from 602 to 792 square feet of building area. Comparable #1 has an inground swimming pool and a pool house. The comparables sold from February 2018 to October 2019 for prices ranging from \$540,000 to \$750,000 or from \$144.01 to 188.53 per square foot of living area, including land.

Based on this evidence the board of review requested confirmation of the subject's assessment.

# **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c).

The Board finds, pursuant to section 16-185 of the Property Tax Code (35 ILCS 200/16-185) a reduction in the subject's assessment is warranted. In pertinent part, section 16-185 of the Property Tax Code provides:

If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel on which a residence occupied by the owner is situated, such reduced assessment, subject to equalization, shall remain in effect for the remainder of the general assessment period as provided in Sections 9-215 through 9-225, unless that parcel is subsequently sold in an arm's length transaction establishing a fair cash value for the parcel that is different from the fair cash value on which the Board's assessment is based, or unless the decision of the Property Tax Appeal Board is reversed or modified upon review.

The Board finds that the subject property was the subject matter of an appeal before the Property Tax Appeal Board for the 2019 tax year under Docket No. 19-08866.001-R-1 in which a decision was issued based upon the evidence presented by the parties reducing the subject's assessment to \$182,840. The record further disclosed the subject property is an owner-occupied dwelling. The Board also finds that the 2019 to 2020 tax years are within the same general assessment period and an equalization factor of 1.0400 was applied in Addison Township in 2020. Furthermore, the decision of the Property Tax Appeal Board for the 2019 tax year has not yet been reversed or modified upon review and there was no evidence the subject property Tax Code would result in a reduced total assessment of \$190,150, which is less than the 2020 assessment of the subject property of \$201,780. Based on the foregoing, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

# **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
