



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: U. Patel & S. Danial

The parties of record before the Property Tax Appeal Board are U. Patel & S. Danial, the appellants, by Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$153,460
IMPR.: \$297,190
TOTAL: \$450,650

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame and brick exterior construction with 3,942 square feet of living area.¹ The dwelling was constructed in 1996. Features of the home include a basement with finished area, central air conditioning, two fireplaces, and a garage containing 620 square feet of building area. The property has a 13,125 square foot site and is located in Hinsdale, Downers Grove Township, DuPage County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument the appellants submitted information on five comparable sales located within .88 of a mile of the subject and within the subject's assessment neighborhood. The comparables consist of two-story dwellings of brick, frame, or brick and frame exterior construction ranging in size from 3,900 to

4,291 square feet of living area.² The homes were built from 1993 to 1997. Each dwelling has central air conditioning, one or two fireplaces, a basement with finished area, and a garage ranging in size from 574 to 701 square feet of building area. The parcels range in size from 11,625 to 17,685 square feet of land area. The comparables sold from January 2019 to June 2020 for prices ranging from \$915,000 to \$1,350,000 or from \$213.24 to \$316.90 per square foot of living area, including land. Based on this evidence, the appellants requested a reduced assessment of \$343,505, for an estimated market value of \$1,030,618 or \$261.45 per square foot of living area, including land, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$450,650. The subject's assessment reflects a market value of \$1,349,252 or \$342.28 per square foot of living area, land included, when using the 2020 three-year average median level of assessment for DuPage County of 33.40% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on six comparable sales located within .94 of a mile of the subject and within the subject's assessment neighborhood. The comparables consist of two-story or three-story dwellings of brick or frame exterior construction ranging in size from 3,604 to 4,327 square feet of living area. The dwellings were built from 1988 to 1999. Each dwelling has one to three fireplaces, a basement with finished area, and a garage ranging in size from 483 to 850 square feet of building area. Five comparables have central air conditioning. The parcels range in size from 9,900 to 22,490 square feet of land area. The comparables sold from June 2018 to August 2020 for prices ranging from \$1,165,000 to \$1,620,000 or from \$269.24 to \$376.48 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

In rebuttal, the appellants argued that board of review comparables #2 through #5 should be given less weight due to their dissimilar design compared to the subject or remote sale date.

Conclusion of Law

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales, or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of 11 comparable sales to support their respective positions before the Property Tax Appeal Board. The Board gives less weight to the board of review's comparables #2 through #5 due to their dissimilar three-story design when compared to the subject. Additionally, board of review comparable #5 sold more remotely in time for valuation as of January 1, 2020.

The Board finds the best evidence of market value to be the appellants' comparable sales and board of review comparable sales #1 and #6, which are similar to the subject in age, dwelling size, location, and features and sold more proximately to January 1, 2020. These most similar comparables sold from January 2019 to August 2020 for prices ranging from \$915,000 to \$1,515,000 or from \$213.24 to \$357.31 per square foot of living area, including land. The subject's assessment reflects a market value of \$1,349,251 or \$342.28 per square foot of living area, including land, which is within the range established by the best comparable sales in this record. Based on this evidence and after considering adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
