

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are James Pappanostos, the appellant, by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago, and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$7,171
IMPR.:	\$18,232
TOTAL:	\$25,403

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of frame and masonry exterior construction with 1,776 square feet of living area. The dwelling is approximately 37 years old. Features of the home include a partial unfinished basement, central air conditioning, a fireplace and a two-car garage. The property has a 10,625 square foot site and is located in Palos Park, Palos Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity concerning the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five equity comparables along with printed property characteristics sheets for comparables which provided basement information.¹ The comparable properties are located in Palos Park, three of which are

located in the same neighborhood code as the subject. The comparables consist of class 2-03 one-story dwellings of frame, masonry or frame and masonry exterior construction. The homes range in age from 37 to 96 years old and range in size from 1,064 to 1,744 square feet of living area. Two of the dwellings have partial or full unfinished basements and three comparables have no basements. Three homes have central air conditioning and three homes each have a fireplace. Each comparable has either a one-car or a two-car garage. The comparables have improvement assessments ranging from \$9,560 to \$13,468 or from \$6.53 to \$9.41 per square foot of living area.

Based on the foregoing evidence, the appellant requested a reduced improvement assessment of \$14,563 or \$8.20 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" setting forth a total assessment of \$25,403. The subject property has an improvement assessment of \$18,232 or \$10.27 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located in Palos Park, within ¹/₄ of a mile from the subject and in the same neighborhood code as the subject. The comparables consist of class 2-03 one-story dwellings of frame, masonry or frame and masonry exterior construction which range in age from 35 to 42 years old. The comparables range in size from 1,440 to 1,794 square feet of living area. Each dwelling has a partial basement, two of which have finished area. Three comparables each have central air conditioning and a fireplace. Each comparable has a two-car garage. The comparables have improvement assessments ranging from \$18,184 to \$18,716 or from \$10.41 to \$12.63 per square foot of living area.

Based on this evidence, the board of review requested confirmation of the subject's assessments.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to appellant's comparables #1, #2 and #3 as each dwelling is significant older than the subject home that is 36 years old.

The Board finds the best evidence of assessment equity to be appellant's comparable #5 along with the board of review comparables which are each relatively similar to the subject in location, design, age, dwelling size and several features. These comparables have improvement

assessments ranging from \$13,468 to \$18,716 or from \$9.41 to \$12.63 per square foot of living area. The subject's improvement assessment of \$18,232 or \$10.27 per square foot of living area falls within the range established by the best comparables in this record. Based on this record and after considering necessary adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
