



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Jill Sapoznick, the appellant, by attorney Eric Feldman, of Eric Feldman & Assoc. P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$9,618
IMPR.: \$54,328
TOTAL: \$63,946

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of stucco exterior construction with 2,972 square feet of living area. The dwelling is approximately 102 years old. Features of the home include an unfinished basement, central air conditioning, one fireplace, an unfinished partial attic, and a 3-car garage. The property has an 8,550 square foot site and is located in Oak Park, Oak Park Township, Cook County. The subject is classified as a class 2-06 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of the inequity argument, the appellant submitted information on five equity comparables located in the same neighborhood code as the subject property. The comparables are improved with 2-story, class 2-05 or class 2-06 dwellings of wood or stucco exterior construction ranging in size from 2,160 to 2,977 square feet of living area. The homes range in

age from 96 to 119 years old. Each comparable has an unfinished basement, one or two fireplaces, and from a 1-car to a 2.5-car garage. Two comparables each have central air conditioning. One comparable has an unfinished full attic. The comparables have improvement assessments ranging from \$31,065 to \$46,758 or from \$12.83 to \$16.06 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$43,629 or \$14.68 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$63,946. The subject property has an improvement assessment of \$54,328 or \$18.28 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located in the same neighborhood code and on the same block as the subject property. The comparables are improved with 2-story, class 2-05 or class 2-06 dwellings of stucco exterior construction ranging in size from 1,636 to 2,521 square feet of living area. The homes range in age from 100 to 107 years old. Each comparable has an unfinished basement, one fireplace, and from a 2-car to a 3-car garage. Two comparables each have central air conditioning. The comparables have improvement assessments ranging from \$37,628 to \$49,487 or from \$19.63 to \$23.00 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine suggested comparables for the Board's consideration. The Board finds the best evidence of assessment equity to be the appellant's comparables #2, #3, and #4 as well as board of review comparable #1 which are more similar to the subject in location, design, age, and dwelling size with varying degrees of similarity in other features. Three of these comparables lack central air conditioning, which is a feature of the subject. Nevertheless, these comparables have improvement assessments ranging from \$40,958 to \$49,487 or from \$13.76 to \$19.63 per square foot of living area. The subject's improvement assessment of \$54,328 or \$18.28 per square foot of living area falls above the range established by the best comparables in this record on an overall basis but within the range on a per square foot basis and is supported. The subject's higher improvement assessment is logical considering its larger dwelling size and amenities when compared to the best comparables. The Board gives less weight to the parties' remaining comparables which are less similar to the subject in dwelling size than other comparables in this record. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate that the subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment based on inequity is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
